Amid a flurry of Nevada blue and medical green, 48 student physicians embraced their new profession at the University of Nevada School of Medicine Academic Hooding Ceremony on May 15.


The now-traditional ceremony drew together 1,200 friends of the school, including Governor Robert List and Congressman James Santini.

In an emotional ceremony highlighted by an espirit d'corps and sense of accomplishment after four arduous years, Nevada's newest physicians received their academic hoods and took the Hippocratic Oath, the code of ethics traditional among physicians since ancient times.

The academic hood, which derives from the everyday mantle worn by medieval clergy, indicates both the school granting the degree and the academic area of specialization. In Nevada, the lining is blue and silver - indicative of the University of Nevada-and the outside stripe is green-the color used traditionally to signify medicine. Each of the graduating physicians invited a fellow physician, professor, or friend who had achieved similar academic levels to confer the hood.

The Class of 1981 honored Dr. J. Malcolm Edmiston of Reno and Dr. William G. Wixted of Las Vegas as Outstanding Community Professors. They chose Dr. Robert N. Hyland of Reno as the Outstanding Full-Time Faculty Member, and designated the Department of Obstetrics and Gynecology (Dr. George J. Furman, chairman) and the Department of Microbiology (Dr. David Lupan, acting chairman) as the outstanding clinical and basic science departments.

The evening's keynote speaker was Dr. Robert J. Glaser, president of the Henry J. Kaiser Family Foundation in Menlo Park, Calif., and a consulting professor of medicine at Stanford University. After giving a perspective of the "incredible progress in medicine" in the last century – including the introduction of penicillin, the discovery of insulin, the development of open heart surgery, the successful treatment of syphillis and tuberculosis, and the apparent conquest of smallpox - Dr. Glaser admonished his listeners to remain humble and to constantly remember that advances bring new challenges and new problems. He added, however, that "problems are in effect opportunities and the greater the problems, the greater the opportunities."


Dr. Glaser challenged the new doctors to remember that the role of the physician, while central, "is properly not one of absolute authority, but rather one of wise counsellor."

And, while the challenges of medicine present a constant upward course, "each of us, in his or her way, can bring honor to ourselves and to the great

Daugherty, Jr. presented Dean's Awards to several special friends of the School of Medicine: Mr. Jake Von Tobel of Las Vegas for his support in the development of numerous medical school programs; Mr. Sol and Mrs. Ella Savitt of Reno for their continuous support of enrichment programs at the School of Medicine, most notably the endowment of the medical library; Dr. Ernest L. Mazzaferri of Reno for his efforts on behalf of the school as acting dean; and Mrs. Edna Brigham of Reno for her continuous and ongoing efforts to develop and enhance the School of Medicine.

profession of which we are a part ... by striving to serve our fellow men more effectively by first identifying and then attacking the unsolved problems that will always confront us," Dr. Glaser concluded.

Governor Robert List reiterated the pride all Nevadans feel in the accomplishments of the School of Medicine after only two years as a full, four-year school. These successes, he said, are exemplified in the Class of 1981, 78 percent of whom are entering primary care medical fields (compared to a national average of 65 percent) and 15 percent of whom are entering family practice (compared to a national average of 12 percent). The Governor also lauded the 13 graduates who are remaining in Nevada to take their residency training.

While congratulating the graduates, Gov. List also expressed the hope that Nevada's newest physicians would be compassionate and caring doctors as they seek to meet the challenges of modern medicine.




Gov. Robert List addresses the 1,200-member audience.

Dean Daugherty charged the graduates "to maintain your tenacity and stamina in order to continue to learn, to prevent disease and to relieve suffering, and, most importantly, to maintain a sensitivity to the needs of your patients and their families and the communities in which your patients live and from which you come, as well as your own needs and those of your families."

The Dean recalled for the graduates the high standards of professional and moral conduct prescribed by the Father of Medicine, Hippocrates, and the ancient's charge to physicians to, first, promote health and, then, prevent illness and cure disease.

Dr. Daugherty also called to mind the philosophy of Sir William Osler, the father of clinical medical education, who warned physicians against selfsatisfied superiority and encouraged "nobility of character, the quality of thoroughness and, above all, the grace of humility."

The new physicians received their diplomas at the traditional commencement ceremonies on the UNR Quad on May 16. They are now settled in residencies from the East Coast to the West, as they seek to develop the wisdom and skills to which medical school was simply an introduction.
