Dear Interested Party:

You have requested to be notified of land management decisions on the Sheep Mountain Allotment in accordance with 43 CFR 4130.2 (b) which requires the authorized officer to consult, cooperate and coordinate with the interested public prior to the issuance of a temporary non-renewable grazing authorization.

The Bureau of Land Management, Tonopah Field Office has received a grazing application from Mr. Berg to graze the Sheep Mountain Allotment. The application is for 175 head of livestock from March 1 to 15, 2009. Mr. Berg is also the grazing lease holder of the allotment. The application does not exceed the grazing preference, but the request is for 15 days beyond the grazing period of the grazing lease. A map of the Sheep Mountain Allotment is enclosed as well as a list of the interested parties. Your input in the future management of the resources is important and will be taken into consideration as the document is being developed.

The proposed decision will be sent to those parties who provide comments. However, before including your address, phone number, e-mail address, or other personal identifying information in your comment, you should be aware that your entire comment – including your personal identifying information – may be made publicly available at any time. While you can ask us in your comment to withhold your personal identifying information from public review, we cannot guarantee that we will be able to do so.


