This letter is to inform you that during the month of December 1995, the Carson City District plans to remove excess wild horses from the Desatoya, Lahontan and South Stillwater Herd Management Areas and associated lands outside of these Herd Management Areas in an attempt to achieve the established appropriate management levels. These removals are a continuation of the actions addressed in the Herd Management Area plans and associated supplemental environmental assessments specific to the above mentioned Herd Management Areas. These removals do not require a decision, since current monitoring data indicates that the established appropriate management levels are still valid and the capture methods remain the same as stated in the management plans and supplemental environmental assessment.

The Carson City District plans to remove approximately 200 horses from both inside and outside of the before mentioned herd areas. As established in the before mention plans and associated documents the appropriate management level will not be changed and the specified number of horses will remain after the removals are completed.
