DECISION RECORD (DR) AND FINDING OF NO SIGNIFICANT IMPACT (FONSI)

Buck and Bald Complex Gather Plan Ely and Elko Field Offices

ENVIRONMENTAL ASSESSMENT Ely NV-040-05-017 Elko BLM/EK-2005-013

Introduction

The Ely and Elko Field Offices (BLM) are planning to conduct a wild horse gather beginning mid-July of 2005 to remove excess wild horses, restoring the range to a thriving natural ecological balance and preventing deterioration of the range. The area to be gathered consists of the Buck and Bald Wild Horse Complex which includes the Buck and Bald Herd Management Area (HMA), Butte HMA, Maverick-Medicine HMA, and the Cherry Creek HMA. The Complex also contains the Humboldt-Toiyabe National Forest Cherry Springs Wild Horse Territory. Past capture, census, and distribution data collected indicate inter-movement among the horses of these herds. The Buck and Bald Complex is located in White Pine and Elko Counties, approximately 30 miles northwest of Ely, Nevada. The Appropriate Management Level (AML) for the Complex is a range of 732-862 wild horses.

The gather plan/Environmental Assessment (Ely E.A. No. NV-040-05-017, Elko E.A. No. BLM/EK-2005-013) has been completed. The E.A. analyzes three alternatives. The Proposed Action in the E.A. is to gather approximately 1,286 wild horses, and remove 780 head. The estimated post-gather population would be approximately 525 wild horses within the Buck and Bald Complex as identified in the E.A. During gather activities, BLM personnel would record data for the captured horses including: sex, age and color; and assess herd health, and sort horses

by age and sex. Selected animals would be returned to the HMAs based on desired characteristics for each herd, and consistent with selective removal criteria. Also as part of the proposed action, BLM would conduct immunocontraceptive research and monitor results. The research would include using the immunocontraceptive drug, porcine zona pellucidae (PZP) vaccine on all of the mares released in the BLM-administered HMA's. This vaccine has been shown to be effective in preventing pregnancy for two years without undesired side effects. The gathers would be conducted by helicopter in about July/August 2005.

Alternative I in the E.A. is the same as the Proposed Action, except fertility control would not be applied. The same numbers of wild horses would be gathered, and selective removal criteria would be applied to remove approximately 780 animals.

The third alternative analyzed is the No Action Alternative. In this alternative, wild horses would not be gathered at this time.

Subsequent to completing the E.A., the BLM flew census during the last week in June, 2005. That census indicates that the population within the Complex may be approximately 2,300 wild horses, which is higher than the previous population estimates which were based on 2001 and 2002 census data. This higher than expected number may be due to the length of time since the last census was flown, increased population recruitment, and/or inter-movement of animals.

FINDING OF NO SIGNIFICANT IMPACT

Based on the analysis of potential environmental impacts in the E.A. for the Buck and Bald Complex Wild Horse Gather (Ely NV-040-05-017, Elko BLM/EK-2005-013), I have determined that the Proposed Action and Alternative I, to include the gathering of excess wild horses, with or without participating in immunocontraception research using the PZP vaccine, will not have a significant effect on the human environment. Therefore, the preparation of an environmental impact statement is not required for compliance with the National Environmental Policy Act of 1969.

Reasons for this finding are based on my consideration of the Council on Environmental Quality (CEQ) criteria for significance (40 CFR 1508.27) with regard to the context and intensity of impacts.

<u>Context</u>: The affected region is limited to the northwest portion of White Pine County and the southern portion of Elko County, where the four wild horse herds are located. The gather has been planned with input from wild horse advocates and other users of public lands.

<u>Intensity</u>: Based on my review of the EA against CEQ's factors for intensity, there is no evidence that the severity of impacts is significant:

1. Impacts that may be both beneficial and adverse. The proposed gather is expected to meet BLM's objective for wild horse management of maintaining a thriving natural ecological balance consistent with other resource needs. Although the gathering and removal of excess wild horses

is expected to have short-term impacts on individual animals, it is expected to ensure the long-term viability of the wild horse herds and help to improve forage and habitat conditions in the herd management areas.

- 2. The degree to which the proposed action affects public health or safety. The proposed gather has no effect on public health or safety.
- 3. Unique characteristics of the geographic area such as proximity to historic or cultural resources, park lands, prime farmlands, wetlands, wild and scenic rivers, or ecologically critical areas. The proposed action has no potential to affect unique characteristics such as historic or cultural resources or properties of concern to Native Americans. No adverse impacts to the Goshute Canyon Wilderness/Instant Study Area are anticipated. There are no wild and scenic rivers, or ecologically critical areas present in the areas. Maintenance of appropriate numbers of wild horses is expected to help make progress in meeting objectives for improved riparian, wetland, aquatic and terrestrial habitat.
- 4. The degree to which the effects on the quality of the human environment are likely to be highly controversial. Effects of the gather are well known and understood. No unresolved issues were raised following notification of wild horse advocacy groups of the proposed gather.
- 5. The degree to which the possible effects on the human environment are highly uncertain or involve unique or unknown risks. The proposed gather includes measures for monitoring its effects on herd population dynamics and toward meeting multiple use objectives for rangeland health throughout the herd management areas. Use of the fertility drug, PZP, to reduce the frequency of gathers and associated impacts, is part of ongoing research to verify that it does not involve unique or unknown risks.
- 6. The degree to which the action may establish a precedent for future actions with significant effects or represents a decision in principle about a future consideration. The action would not establish a precedent for future actions with significant effects or represent a decision in principle about a future consideration.
- 7. Whether the action is related to other actions with individually insignificant but cumulatively significant impacts. The EA includes an analysis of cumulative effects which considers past, present and reasonably foreseeable future actions in the Buck and Bald Complex, that supports the conclusion that the proposed gather is not related to other actions with individually insignificant but cumulatively significant impacts.
- 8. The degree to which the action may adversely affect districts, sites, highways, structures, or objects listed in or eligible for listing on the National Register of Historic Places or may cause loss or destruction of significant scientific, cultural, or historic resources. The proposed gather has no potential to adversely affect significant scientific, cultural, or historical resources.
- 9. The degree to which the action may adversely affect an endangered or threatened species or

its habitat that has been determined to be critical under the Endangered Species Act of 1973. The action is not likely to adversely affect any listed species, and the action area does not include any habitat determined to be critical under the Endangered Species Act.

10. Whether the action threatens a violation of Federal, State, local or tribal law or requirements imposed for the protection of the environment. The proposed gather conforms to the approved Egan Resource Management Plan, the Wells Resource Management Plan and amendments, and is consistent with other Federal, State, local and tribal requirements for protection of the environment to the maximum extent possible.

DECISION

It is our decision to implement Alternative I, as described in the EA for the Buck and Bald Complex Wild Horse Gather (Ely NV-040-05-017, Elko BLM/EK-2005-013). Up to 1,286 wild horses will be gathered, selective removal criteria will be used to sort the wild horses, and approximately 780 wild horses will be removed. During the gather operation, BLM will also be evaluating whether to return to the Complex later in the year to conduct a follow-up gather. Additional census may be scheduled after the July gather to determine distribution and numbers of the remaining animals, and if a follow-up gather is necessary.

Rationale

- 1. The gathering and removal of excess wild horses is being selected to ensure a "thriving natural ecological balance" as well as preserve the multiple use relationship within the Buck and Bald, Butte, Maverick-Medicine and Cherry Creek HMAs immediately and over the next several years. Further, this action is needed to prevent vegetative and riparian resources from deterioration associated with an overpopulation of wild horses.
- 2. The gather conforms to the Egan Resource Management Plan and Final Environmental Impact Statement (FEIS) dated December 24, 1983, and resolution of protests received on the proposed RMP and FEIS documents dated September 21, 1984, and the Egan Resource Area Record of Decision (ROD) which was finalized February 3, 1987. It also conforms to the Wells Resource Management Plan approved July 1985, the Wells Resource Management Plan Wild Horse Amendment, as approved August 1993. It is further consistent with other Federal, State, local and tribal policies and plans to the maximum extent possible.
- 3. The AMLs were established for each HMA through Final Multiple Use Decisions (FMUD) for the affected Allotments. The AML for the Complex is a range of 732-862 wild horses.
- 4. Alternative I was selected due to the possibility of needing a follow-up gather later in the year. Fertility control research would be more appropriately applied during a later gather.
- 5. The No Action Alternative was not selected because it would not allow for the removal of wild horses to preserve the multiple use relationship within the area and help to make progress in

meeting objectives for wild horses and riparian, wetland, aquatic and terrestrial habitat.

Public Involvement

Public notification and scoping of B.A. Ely NV-040-05-017, Elko BLM/EK-2005-013 was sent to the persons, groups, and agencies listed on pages 30-32 of that document on May 24, 2005, with a 30-day review and comment period. Four comment letters were received during the public scoping period. Comments pertaining to the Buck and Bald Complex Gather Plan and EA were submitted by Western Watersheds Project, Boise, Idaho, John C. Carpenter, Assemblyman, District 33, Nevada, Barbara Warner, AHDF KY SC, Marion County Humane Society, Lebanon, Kentucky, and Elko County Board of Commissioners, Elko, Nevada. A summary of the results of public scoping is in pages 33-35 of the EA. All input received was considered in relation to the analysis and the formulation of a decision.

Appeal Procedures

Your appeal must be filed within thirty (30) days from receipt of this decision. The appellant has the burden of showing that the decision appealed from is in error.

If you wish to file a petition pursuant to regulation 43 CFR 4.21 (58 FR 4942, January 19, 1993) for a stay (suspension) of the decision during the time that your appeal is being reviewed by the Board, the petition for stay must accompany your notice of appeal. Copies of the notice of appeal and petition for a stay must also be submitted to:

A copy must also be sent to the appropriate office of the Solicitor at the same time the original documents are filed with the above office.

If you request a stay, you have the burden of proof to demonstrate that a stay should be granted. A petition for a stay is required to show sufficient justification based on the following standards:

- 1. The relative harm to the parties if the stay is granted or denied.
- 2. The likelihood of the appellants success on the merits.
- 3. The likelihood of immediate and irreparable harm if the stay is not granted.
- 4. Whether the public interest favors granting the stay.

The Office of Hearings and Appeals regulations do not provide for electronic filing of appeals, therefore they will not be accepted.
