## **Proceedings Dismissed**

The respondent's Motion to Dismiss Docket Numbers NV-4-94-02 and NV-4-94-03 (IBLA 94-626) for lack of continued standing is hereby granted. Exhibit A to respondent's referenced Motion clearly establishes that appellant Russell's ownership of the subject base property for the Warm Springs allotment was terminated by a Trustee's Sale on or about October 25, 1994, and the base property was purchased at that sale by appellant Metropolitan Life Insurance.

Pursuant to the provisions of 43 CFR 4110.2-l(d), when appellant Russell lost ownership of the base property pursuant to the Trustee's Sale, he also immediately and automatically lost his Federal permit or lease by operation of the referenced regulatory provision. Consequently, appellant Russell no longer has standing to pursue this appeal, and the respondent's Motion, based upon the referenced jurisdictional grounds, is hereby granted. *Colorado Open Space Council and Sierra Club v. Bureau of Land Management*, 109 IBLA 274 (1989).

It is noted that the other still pending appeals in this matter remain jurisdictionally unaffected by this Order, and, consequently, Docket Numbers NV-04-94-04, NV-04-94-05,

and NV-04-94-06, remain set for hearing, as previously scheduled, for Monday, May 15, 1995, at 1:30 P.M. in Ely, Nevada, at the Bristlecone Convention Center.
