

## Notice of Closure Agreement

Severe drought conditions exist within the Henrie Complex Allotment. The allotments were recently visited to evaluate drought conditions. Field observations indicate that available forage and water availability is limited and that severe drought conditions exist. Precipitation for the normal growing season of April, May, and June is 50% of normal. The below normal precipitation has resulted in decreased soil moisture and water availability, decreased plant vigor and growth while some locations have little or no current year's growth. The allotment is managed within the Blue Nose Peak Wild Horse Herd Management Area (HMA), and the Mormon Mountains HMA and the Meadow Valley Mountains HMA. The area affected by this closure is west of the Union Pacific Railroad and only affects the Meadow Valley Mountains HMA. See attached map for more detailed description of the closure area. Grazing may occur in other areas of the allotments until use limits have been met during the established grazing season only.

Therefore, for the protection of the vegetation and watershed due to severe drought conditions, the **Henrie Complex** Allotment is hereby temporarily closed to livestock grazing. This Notice of Closure is effective immediately.

The closure will be in effect until the following criteria have been met:

- 1. Vegetative growth occurs and can sufficiently support livestock grazing; and
- 2. The key forage species all show good vigor; and
- 3. Soils are sufficiently protected from potential erosion.

Upon determination that the perennial vegetation has been re-established, authorized grazing use will resume. We will ask for the permittees' participation when evaluating forage conditions associated with lifting this closure. A map of the closure area is attached. This closure is issued as an agreement pursuant to Title 43 Code of Federal Regulations, Section 4110.3-3 (b).

This Notice is to inform you that any unauthorized livestock grazing upon public lands within the **Henrie Complex Allotment** (Legal description T. 5, 6, 7 S., R. 67, 68 E. under Bureau of Land Management's control will be in violation of 43 CFR 4140.1 (b) (1) and may be impounded. The unauthorized livestock may be impounded at any time after five (5) days from delivery of this notice or after five (5) days from the publishing and posting of this notice. This notice is issued in accordance with 43 CFR 4150.4; any impoundment of unauthorized livestock in connection with this notice will be done in accordance with 43 CFR 4150.4-2.
