Thank you for the opportunity to participate in the allotment evaluation process. We wish to be considered an interested and affected party as our concern is for the protection of wild horses and their habitat.

We wish to be included in the re-evaluation process for the Buffalo Hills, Leadville, Blue Wing, and Seven Troughs Allotments.

Our main concern for the wild horses during the allotment evaluation process is who ate what....when and where.

Some of the information we would need to evaluate the allotment in question would be:

- 1) Actual Livestock Use
 - (a) Actual Use Reports
- 2) Season of Use by Wild Horses
- 3) Season of Use by Livestock
- 4) Seasonal Census...showing where the majority of wild horses graze during seasonal yearly movements.
- 5) Use Pattern Mapping
- 6) Location of water used by livestock and wild horses.
- 7) Map of the HMA in relationship to the allotment that shows distribution of horses, cows, and water.

Any specific conclusions or technical recommendations you present in any of the allotments in question should be thoroughly defined, well documented statements that support your decisions to maintain the public lands in a thriving natural ecological balance and prevent a deterioration of the range.

Searching my files, I have found that I am lacking quite a bit of forehand information from the Winnemucca District. Since I have been here for two years and in this position for the last

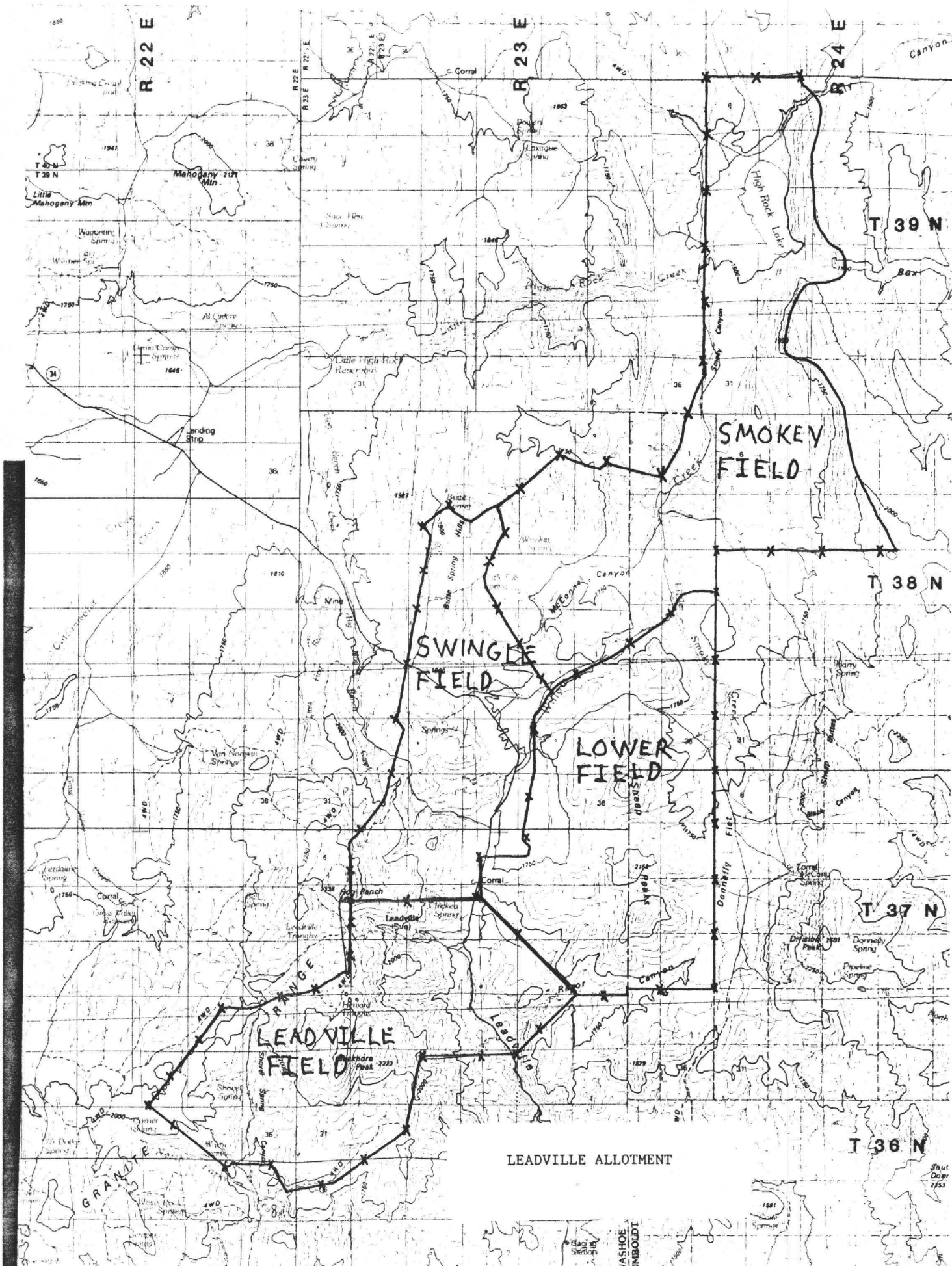
