13 Appellants and Respondent hereby notify the Administrative Law
14 Judge (ALJ) that the above appeals of the 1994 Full Force and
15 Effect Multiple Use Decision for the Leadville Allotment (the
16 Decision) are withdrawn. Appellant Connecticut General Life
17 Insurance Company, as indicated in a September 21, 1995 letter to
18 the ALJ, is no longer associated with the Leadville Grazing
19 Allotment. Appellant Michael B. Stewart accepted the terms and
20 conditions of the Decision when the grazing permit held by
21 Connecticut General was transferred to him on April 21, 1995. (See
22 Att A; 43 C.F.R. § 4110.2-3(a)(3)). Therefore, both Appellants
