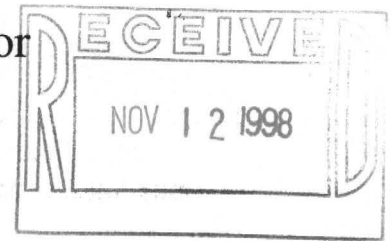

Dear Mrs. Goring

Your grazing permit for the South Pasture of the UT/NV #1 Allotment will expire on October 31, 1998 and must be renewed prior to authorization to graze on public lands for the 1998-1999 grazing season. In order to authorize your 1998-1999 grazing use, we need to have the attached "Acceptance of Terms and Conditions" form signed and returned as promptly as possible. The term of this permit will be from November 1, 1998 to October 31, 2001. Upon renewal of the lease, a new permit would be issued for the term of the lease not to exceed 10 years. If the lease is not renewed, the permit will revert back to Darrel Kippen and Sons.

The new grazing regulations also require the authorized officer to consult, cooperate, and coordinate with affected permittees, the State agencies having lands or responsible for managing resources within the area, and the interested public prior to the issuance or renewal of grazing permits (43 Code of Federal Regulations 4130.2(b)). Therefore, a copy of this letter, a copy of the terms and conditions, and a map showing the location of the South Pasture of the UT/NV #1 Allotment will be sent to anyone who has expressed an interest in the UT/NV #1 Allotment. **The interested public is being asked to provide comment by November 24, 1998.** You will be notified of any changes to terms and conditions that may be warranted as a result of comments received.

The South Pasture of the UT/NV #1 Allotment is located within the **Antelope Valley Herd Management Area (HMA).**

The terms and conditions outlined are consistent with the Wells Resource Management Plan and have been analyzed in the Wells Resource Management Plan Environmental Impact Statement.

REQUEST FOR GRAZING PERMIT

I, Sherie R. Goring, agree to accept the Terms & Conditions listed below and request that I be offered a Grazing Permit to graze the allotment in which I have a grazing preference.

*Terms and Conditions:*

There are 3,249 historic suspended AUMs attached to this grazing permit.

Grazing use of the existing administrative sheep trail other than for trailing is prohibited.

The term of the grazing permit will be for the period of the lease (initially 3 years) with renewals approved concurrent with the lease up to 10 years.

The above grazing schedule is annual use authorized as a temporary deviation from the Utah/Nevada No. 1 AMP, pending completion of the allotment evaluation and decision process. Payment of grazing fees will be made prior to livestock turnout.

Actual use data on all pastures must be submitted to this office within 15 days from the last day of use.

Pursuant 43 CFR 10.4(g) the holder of this authorization must notify the authorized officer, by telephone, with written confirmation, immediately upon the discovery of human remains, funerary items, sacred objects, or objects of cultural patrimony. Further, pursuant to 43 CFR 10.4(c) and (d), you must stop activities in the immediate vicinity of the discovery and protect it from your activities for 30 days or until notified to proceed by the authorized officer.

Supplemental feeding is limited to salt, mineral, and/or protein supplements in block, granular, or liquid form. Such supplements must be placed at least ¼ mile from live waters (springs and streams), troughs, wet or dry meadows, and aspen stands.

All riparian enclosures, including spring development enclosures, are closed to livestock use unless specifically authorized in writing.

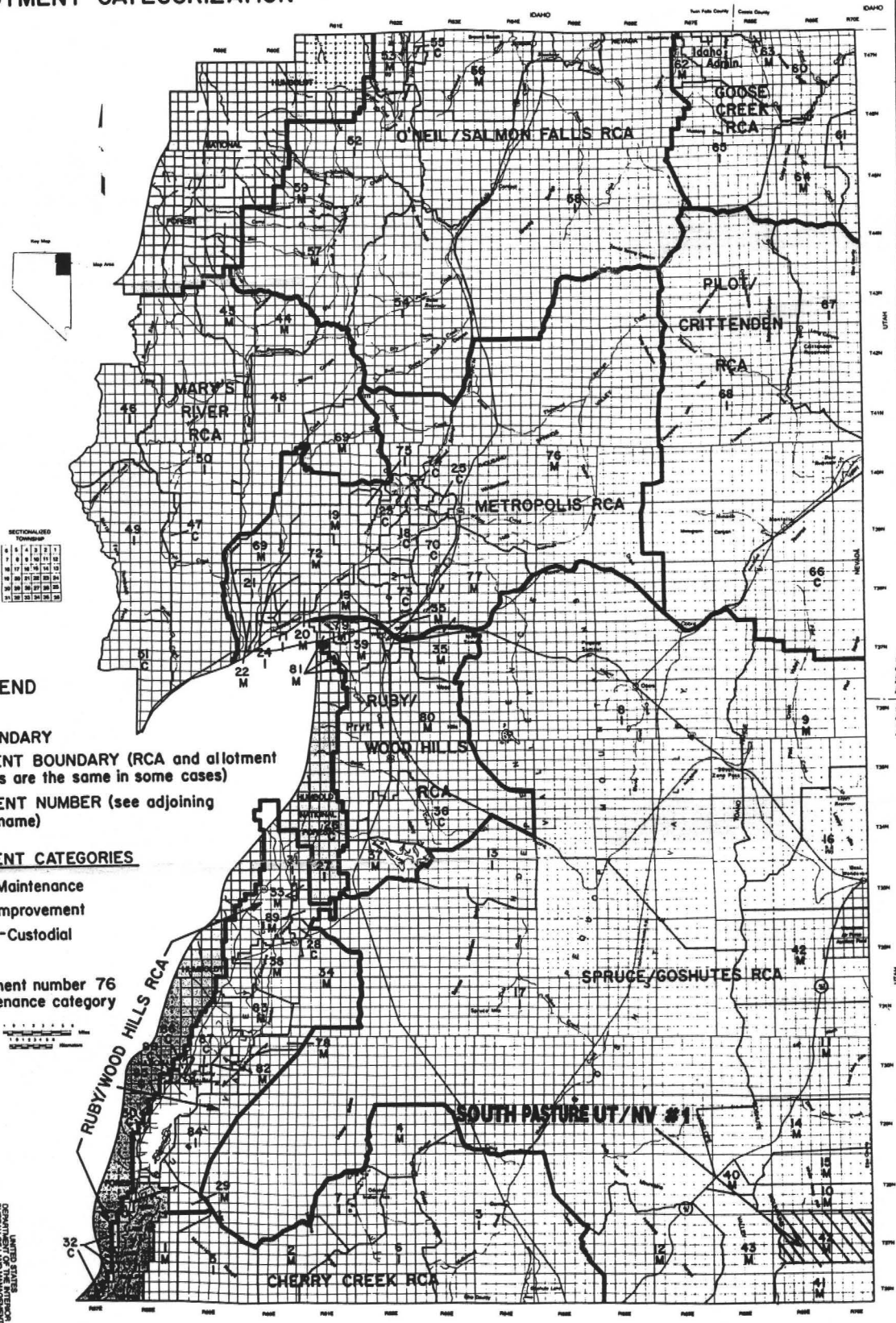
Payment of grazing fees is due on or before the due date specified on the grazing bill. Failure to pay the grazing bill within 15 days of the due date specified on the bill shall result in a late fee assessment of \$25.00 or 10 percent of the grazing bill, whichever is greater, but not to exceed \$250.00.

The term of this permit would be from November 1, 1998 to October 31, 2001.
