





As a followup to the telephone conversation that our Forest Lands Assistant, Randy Karstaedt, recently had with Bob Flewelling of your office, enclosed is a portion of our forest map showing the location of the scattered inholdings we are interested in acquiring. These parcels total approximately 200 acres and are owned by Mr. Willie Wolfe, P.O. Box 427, Mina, Nevada, 89422; phone number (702) 573-9900.

The parcels contain some of the important sources of water (springs) in this large portion of the Inyo National Forest known as the "Pizona Area". As such, these parcels serve as gathering and critical foaling areas for a wild horse herd which inhabits this area in Nevada and California. All of this land, except for a very minute part of one parcel, is located in Nevada near the California border. A critical action identified in our Montgomery Pass Coordinated Resource Management Plan (prepared in 1988) is the acquistion of the private land inholdings for the future protection of the wild horse territory.

Over the past few years, we have discussed the possibility of a land exchange with Mr. Wolfe, whereby he was interested in acquiring some National Forest lands along U.S. Highway 6 near the Nevada-California border in exchange for the subject parcels. However, Mr. Wolfe recently indicated to us that he would also consider sale of the parcels to a third party if he receives a price that he feels is reasonable and, therefore, avoid personally incurring his costs of a direct land exchange with us.

Your organization might be able to serve as that third party entity, should you be willing to do so. There is a considerable amount of interest in the Forest Service acquiring title to these parcels and managing them for wild horse habitat. Consequently, the National Mustang Association has offered to fund an appraisal of these parcels which you could use as a basis in your negotiations with Mr. Wolfe. A person you can contact to discuss this further is:

Attached is a copy of our recent correspondence with Mr. Sewing for your information.

Your role as an intermediary owner of these parcels would probably be one in which you either enter into a subsequent land exchange directly with the Forest Service, or in turn offer the property to an exchange proponent. We are working with another case that needs such land to offer us to make an exchange possible. In either case, current exchange authorities limit us to consider National Forest lands only within the State of Nevada for the parcels. However, those lands would not necessarily need to be located within the Inyo National Forest, but could be within any National Forest in Nevada. We've already informed Toiyabe National Forest Realty Specialist, Marcia Joseph, about this case, and she is willing to discuss with you the identification of National Forest lands within the Toiyabe which your organization might wish to acquire in exchange for these parcels. Unfortunately, it's our opinion that these parcels may not even qualify for direct purchase funding under the Land and Water Conservation Fund, thereby eliminating the option of direct purchase from you.


I will try to keep in touch with you on the progress of the land exchange, as I feel that it is the best approach.
