Program Outlook for Fiscal Year 1981 (October 1, 1980 - September 30, 1981)

Approximately \$6,660,000 has been allocated to BLM for wild horse and burro program activities in Fiscal Year 1981. Final adjustments for each State's wild horse and burro program have not been completed; however, Bureauwide goals for Fiscal Year 1981 have been established:

- About 20 million acres of wild horse and burro habitat will be inventoried. The inventories will describe the forage and habitat conditions by herd area, identify migratory habits, and provide an estimate of the population by herd area. Eight Herd Management Area Plans will be developed. Particular emphasis will be placed on implementing the recently approved California Desert Conservation Area Plan.
- Approximately 8,500 excess wild horses and 2,000 excess wild burros will be removed from the public lands. Half of the horses will be removed from Nevada's public lands and two-thirds of the burros will be removed from the California Desert Area.
- A contract will be negotiated to open an additional adoption center next summer in the midwest. The center will be under the jurisdiction of BLM's Wyoming State Office.
- Compliance checks of about 1,000 adopters will be made. The adopters will be visited by BLM personnel, who will inspect animals previously assigned under the adoption program.
- By the end of Fiscal Year 1981, adopters of more than 7,500 horses and burros will become eligible to apply for titles of ownership. Title applications are processed by BLM field offices and titles will be issued to qualified adopters.
- Contracts for two additional wild horse and burro research projects will be issued. The research projects will be selected from 18 studies recommended by the National Academy of Sciences. Contracts for four other studies were issued during FY 1980.

# Field Office Program Accomplishments During October - November 1980.\*

#### Management

In November, formal dedication ceremonies were held to establish the Little Book Cliff Wild Horse Range in memory of Velma (Wild Horse Annie) Johnston. Between 80 and 100 wild horses will be managed by BLM on the range. About 180 people attended the dedication ceremonies.

## Removal of Excess Animals

Seven States reported removals in October and November. Arizona and California captured nearly 550 burros. Nearly 1,500 wild horses were captured in Arizona, California, Idaho, Montana, New Mexico, Oregon, and Wyoming. The removals were conducted primarily to implement planning decisions. Wyoming gatherings (about 800 horses) were designed to remove wild horses from private lands and prevent range deterioration on public lands. Forty old, sick, and lame animals were destroyed and an additional 46 animals died after capture and prior to adoption.

## Adoptions

During October and November, more than 1,000 horses and 250 burros were placed under adoption. Two unadoptable horses were humanely destroyed in Oregon.

#### Compliance/Enforcement

More than 300 horses and burros were inspected to ensure that adopters were providing humane care and proper treatment. About 60 horses and 4 burros were repossessed from adopters due to improper treatment. Six new investigations were started by four offices. The cases, involving 53 adopted horses, range from neglect and sale to use as bucking stock.

#### Public Information and Involvement

BLM personnel in California and Idaho gave presentations on their wild horse and burro programs to more than 320 people, while a scheduled hearing on an Idaho gathering drew no attendance.

#### Title Transfers

Titles to 634 adopted horses and 100 burros were issued to adopters during October and November.

# Washington Office Activities

Two personnel changes occurred in the Division of Wild Horses and Burros: Bob Springer transferred to the Wyoming State Office, where he will coordinate the NAS-designed research studies and Wyoming's horse and burro program; and Barbara Maxfield joined the Division staff as a writer-editor.

Two major program documents were recently released: the Third Report to Congress on the administration of the wild horse and burro program (a joint report by BLM and the Forest Service; copies are available from all BLM Offices); and a guidance statement for BLM Offices involved in the wild horse and burro program (copies are available upon request - Instruction Memorandum No. 81-145).
