COOPERATIVE AGREEMENT

Range Improvement and Conservation Practices

1. We, the United States Air Force (USAF), the Department of Energy (DOE), and the Bureau of Land Management (BLM), hereinafter called cooperators, for and in consideration of the mutual benefits hereunder, and in accordance with the Taylor Grazing Act (43 U.S.C. 315, 315a-4), as amended, and the National Soil Conservation Act (16 U.S.C. 590a-q(1)), as amended, do enter into this construction of a range improvement known as the Air Force Withdrawal Fence (hereinafter referred to collectively as the improvement), for the benefit of the public lands and of the cooperator(s).
2. The improvement will be constructed along the northerly boundary of Nellis Air Force Range, upon public land located within the Counties of Nye, Esmeralda, and Lincoln, State of Nevada (see attached map, hereby made a part of this Cooperative Agreement).
3. It is mutually agreed, as outlined in paragraph 4 below, that the parties hereto will make monetary contribution for construction costs of the improvement as outlined in the attachment. The cost may vary and will be adjusted to reflect inflationary costs when construction is completed.



4. BLM will inspect and maintain the completed improvement as needed, but no less than once annually. The actual cost of such maintenance will be borne by the three cooperating agencies in the same proportion as their respective contributions to constructing the improvement. BLM will absorb its proportionate share of the maintenance cost.

USAF and DOE will reimburse BLM their proportionate share of maintenance costs upon annual billing by BLM.




