RECORD OF DECISIONS/RATIONALE AND FONSI AMENDMENT

Decision and Finding of Impacts of Proposed Action Amending NWHR & NRC Gathering Plans.

The implementation of the proposed action of using a second helicopter to supervise the project helicopter, and assure for the well being of the Wild Horses as they are gathered will provide positive impacts as identified in the analysis. Therefore, the proposed action amending NWHR & NRC Gathering Plan is accepted as written.

Rational

This amendment to the NWHR and NRC Gathering Plan was developed through a public review process incorporating comments into the document. The proposed action as specified in the amendment is expected to result in positive impacts to wild horses. AMENDMENT

This amendment incorporates the following stipulations to be attached to the Nevada Wild Horse and Nellis Range Complex Gathering Plan, dated March 18, 1985, covering use of helicopters for contract supervision.

INSPECTION OF CONTRACT SERVICES

The Bureau of Land Management will provide supervision of the project helicopter during the gathering operation. This will be accomplished by use of an additional helicopter on site to monitor all aspects of the wild horse round-up. In the event an additional helicopter cannot be obtained, or proper clearance arranged to allow access to the Nellis Range Complex (for the additional helicopter), other methods will be used to observe the removal operations, including but not limited to, using observers on horseback, observing the helicopter from vehicles and placing stationary observers in strategic locations. The observers will have direct communication with the project helicopter for contract supervision.

AMENDMENT to EA #NV-057-4-05 This amendment adds the following actions to the above referenced EA as necessary to address impacts.

III. PROPOSED ACTION:

The proposed action is for Bureau of Land Management to use a second helicopter to supervise the project helicopter, and assure for the well being of the wild horses as they are gathered. Also in the event, that for what ever reason, a second helicopter cannot be obtained then observers would be placed at strategic geographic locations to observe the project helicopter and assure for the well being of the wild horses.

V. ENVIRONMENTAL CONSEQUENCES OF THE ADDITIONAL PROPOSED ACTIONS:

There may be beneficial impacts to the wild horses as a result of this action, such as reducing injuries through better supervision of the project helicopter. The proposed action will cause no additional impacts on Wilderness, Threatened/Endangered Plants or Animals, Vegetation, Wildlife, Visual Resource Values, Wild Horses, or Cultural Resources.

VI. CONSULTATION AND COORDINATION

This plan Amendment was available for public review by all interested persons, and organizations, the Consultation and Coordination Committee members, and the Five Party Cooperative Agreement Committee members for a period of 30 days. Comments were received from the Nevada Department of Wildlife, and the Wyoming advocates for Animals; both groups gave support to the proposed action.

This plan amendment also went through intensive internal review (Nevada State Office, District, and Resource Area Offices) with comments being incorporated into the plans as appropriate. Resource Area personnel reviewing the plan amendment and the Environmental Assessment were:
