REVIEW OF DAWN LAPPIN'S 8/13 & 14/87 REPORT

RELATING TO

SORE FOOTED AND SICK HORSES AT PVC

The numbers in this report refer to the handwritten and circled number entries on Mrs. Lappin's report.

- 8262 Nellis Gather July 87 Injured on Truck Completely Recovered - Shipped to Texas
- 2. 0240 Callaghan Gather August 87 Injured at PVC Completely Recovered Shipped to Texas
- 3. 0012 Sand Springs Gather July 87 Sore Footed Completely Recovered Shipped to Nebraska
- 4. 7491 & 8191 Nellis Gather June 87 Completely Recovered 7491 Shipped to Nebr. 8191 Shipped to Texas Some of the Nellis animals do show signs of sore footedness. This is not due to capture, they do have badly worn hooves which is attributed to the long distances they travel for water and forage at Nellis. None of the Nellis animals required treatment for sore footedness and none have abscessed.
- 5. Roberts Mountain Gather Arrived PVC 8-13-87 Traveled long distance, horses were tired, were not worked for a couple of days, allowed to rest. Buckskin colt had gash on rear leg--Mrs. Lappin took several pictures of this injury. Colt arrived with the injury, may have occurred on the truck or loading ramp, we really don't know. Colt treated 8-14 & 15 and 8-22 & 29. Colt fully recovered and now with mare in Lovelock. We do not agree that the several animals listed were lame. They were tired and did show some symptoms of sore footedness, but none required treatment all fully recovered in a day or two and all have been shipped out. Majority shipped to Nebraska and Texas, a few went to Lovelock.
- 6. All horses from Callaghan Gather August 87 Did have sore feet, 1 colt treated for abscess, all animals fully recovered within a few days without further treatment except 0346 which was euthanized on 8-18 due to a joint injury not associated with sore footedness, but probably kicked. 0354 is a brown stud, must have been a mix-up in reading numbers. The animals were shipped to Texas.

- 7. All horses from Callaghan Gather August 87 Did have sore feet, all recovered within a few days without treatment, except for 0474 which was a mare in poor condition and had an abscess that was not related to sore feet. 0474 was euthanized on 8-26. All shipped to Texas except 3 went to Lovelock.
- 8. All horses from Callaghan Gather except 0139 which was from Sand Springs. Did have sore feet, all recovered within a few days without treatment. Shipped to Texas and Nebraska.
- 9. All from Nellis Gather except 0664 which came from Roberts Mtn. These Nellis animals did not show signs of sore footedness, some may have shown signs of limping, which may be attributed to distances they travel for water at Nellis. None were treated and all signs of limping were gone in a day or two. Shipped to Texas and Nebraska. (See 4 Above) 7301 was euthanized 9-2-87 for a broken leg, probably kicked.
- 10. All Callaghan Gather We do not agree with the analysis of sore footedness in this pen. Some did show signs of limping, but this is not a condition of major sore footedness as apparently observed by Mrs. Lappin. One colt did have sore feet and was treated for abscess this colt fully recovered. 0387 was a puncture wound, we do not know where or how this happened. Often these are small wounds and we do not observe them until they abscess. This wound was treated and the animal fully recovered. All these animals went to Texas except 0428 went to Lovelock. 0428 cuts were treated and the colt and mare were shipped to Lovelock on 9-16.
- 11. Pen 27 is the mare sick pen, the nose and head cuts occur at about a 50 PVC/50 Field ratio due to animals striking the sides of the pens or the chutes at PVC or during sorting and separating mares and studs at the capture site. These animals are put in the sick pen specifically for treatment and recovery.

- 12. All Sand Springs Gather minor sore footedness, fully recovered in a few days, no treatment required. All shipped to Texas.
- 13. Both Animals from Nellis Stud Sick Pen Both Treated and Fully Recovered: 7327 Lovelock & 7909 Nebraska

- 14. Callaghan Gather Treated, Fully Recovered Shipped to Texas
- 15. See 5 above. This was not a puncture wound. It was a long scrape wound which probably occurred when the colt stepped through the loading ramp and tore the skin while pulling its leg free.
- 16. Sand Springs Gather Treated, Fully Recovered Shipped to Nebraska
- 17. Callaghan Gather Treated, Fully Recovered Shipped to Lovelock
- 18. Callaghan Gather Sorrel Horse not Black Treated, Fully Recovered Shipped to Texas
- 19. No animal identified.
- 20. Callaghan Gather Treated, Fully Recovered Shipped to Lovelock. This animal is a three-month old male colt, not a mare.

SUMMARY

Between the second week of June and the time Mrs. Lappin arrived (8-13) to view the animals, approximately 2250 animals had been captured and processed. The majority of these animals had already been shipped and the animals Mrs. Lappin observed were those that showed signs of limping and were being held until fully recovered. Only three animals were euthanized as a result of sore footedness. Two were Sand Spring horses (0098 and 0126) that developed sole abscesses and had to be destroyed and one was a Callaghan horse (0274) that developed a sole abscess.

8-13-1987..FIELD REPORT BY DAWN LAPPIN

On August 13, 1987 I arrived at Palomino Valley Holding Facility to film with Channel 4 and 8, stories pertaining to 8 orphan colts that needed homes. After filming Terri Jay and myself went to look at two really nice paint horses; in that pen we noticed some very lame horses. I spoke to Fred Wyatt generally about why the animals were lame and he responded that he had a few lame animals, but that he had talked to people about it. Friday evening I received a call from some people who had been at Palomino and stated that they had seen many lame animals.

8-14-1987..FIELD REPORT BY DAWN LAPPIN

I returned to Palomino the next morning. I asked Fred Wyatt if I could check all the individual corrals. He said he had to load some horses and would be right with us. I went into all the corrals except the two fields and the two front pens nearest to the office. I requested from the office, the bleed sheets, and the death records.

Many of these animals showed signs of previous treatment, such as bandaged hooves, disinfectant. Asked Fred Wyatt how many animals would need treatment, he said the veterinarian and he would be working Saturday on injured animals. I asked to come back.

I left Palomino and went to the Nevada State Office of the Bureau of Land Management. I spoke briefly to Milt Frei, he took copies of my field notes, BLM bleed sheets, death records. I spoke to Mr. Wolfe regarding the fact that BLM had assured me over one year ago that excessive running of horses would not be tolerated. Instruction Memorandums were issued and a chase helicopter assigned. I informed Mr. Frei and Mr. Wolfe that I had newspaper sources as well as the visual medium that would gladly address this cruelty if BLM wasn't willing to do so.

I asked how much the veterinarian charges were. I was informed he receives \$25 for the trip, \$29.00 an hour, plus the charges for injections and treatment.

Upon arrival I stated that I would be taking pictures of the actual injuries. I made it very clear that I was distressed at the number of abcessed and worn hooves, in addition to the large number of injuries. It appeared that the animals were suffering from a similar situation that occurred just one year ago when animals were excessively run. Fred Wyatt said he had called Bob Brown in Ely regarding the sore footed horses from Sand Springs, but that he had only talked to the contractor regarding his concern on Callahan, Roberts Creek, but that generally he thought it had improved some. (It is my own opinion that troubles relating back to the Carson City District, whom I believe have undermined Mr. Wyatts' attempt to run a goodship, have gotten around to the other districts. If he reports excessive injuries they claim he is crying. I don't believe this problem will disappear unless the State Office oversees Palomino, rather than the District.) I have stated for over a year that the Districts were not listening and didn't care about the sensitivity at Palomino, and the repeat this year confirms they do not care animals are suffering. The following were only a few pictures of the work on injured animals that took the entire day, I believe they reflect an uncaring agency and an irresponsible I personally have flown on capture operations with the Bureau and have attended roundups for nearly 15 years. recognizant of the fact that wild animals will get injured at the capture sight, in transport, and at the holding facility; however the degree of injuries has risen since BLM started contracting the capture operations, due to the profit and expediancy of the private contractor. Despite repeated warnings, disasters, the Bureau refuses to rectify the cruelty.

In each one of the treatment cases the following occurs:

- 1. a horse back rider must retrieve the animal from the pens holding the horses, meaning it must be separated from healthy animals.
- 2. the horse is brought to the squeeze chute
- 3. the animals head is roped, and the squeeze chute tightened
- 4. depending upon the injury, the animal would have to be injected with a paralytic drug (sucostrin).
- 5. waiting four or five seconds, the animal collapses, momentarily loosing the ability to breath. The drug only lasts a few minutes.

- 6. The animal must have his/her legs restrained by rope.
- 7. The wound is opened by scraping.
- 8. The wound is washed with antiseptic (Betadine), wrapped, if necessary.
- 9. The animal is released
- 10. The animal must be put in an area where it can be retrieved for repeated treatment.

SUCOSTRIN IS A PARALYTIC DRUG THAT CAN CAUSE DEATH IN A STRESSED ANIMAL. On such animal was witnessed by my husband, Bert, when the animal was given the sucostrin, its heart failed, and the vet had to jump on it to bring it back.
