AMENDMENT to EA #NV-057-4-05 This amendment adds the following actions to the above referenced EA as necessary to address impacts.

## III. PROPOSED ACTION:

The proposed action is for Bureau of Land Management to use a second helicopter to supervise the project helicopter, and assure for the well being of the wild horses as they are gathered. Also in the event, that for what ever reason, a second helicopter cannot be obtained then observers would be placed at stratigic geographic locations to observe the project helicopter and assure for the well being of the wild horses.

## V. ENVIRONMENTAL CONSEQUENCES OF THE ADDITIONAL PROPOSED ACTIONS:

There may be benificial impacts to the wild horses as a result of this action, such as reducing injurys through better supervision of the project helicopter. The proposed action will cause no additional impacts on Wilderness, Threatened/Endangered Plants or Animals, Vegetation, Wildlife, Visual Resource Values, Wild Horses, or Cultural Resources.

## AMENDMENT

This amendment incoporates the following stipulations to be attached to the Nevada Wild Horse and Nellis Range Complex Gathering Plan, dated March 18, 1985, covering use of helicopters for contract supervision.

#### INSPECTION OF CONTRACT SERVISES

The Bureau of Land Management will provide supervision of the project helicopter during the gathering operation. This will be accomplished by use of an additional helicopter on site to monitor all aspects of the wild horse round-up. In the event an additional helicopter cannot be obtained, or proper clearance arranged to allow access to the Nellis Range Complex (for the additional helicopter) the COR and/or PI will be placed at stratigic geographic locations to allow for continuous observation of the project helicopter during the entire gathering operation. The observers will have direct communication with the project helicopter for contract supervision.
