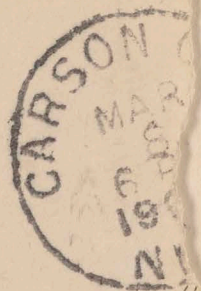

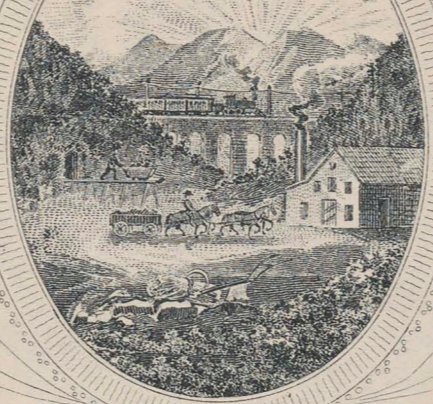

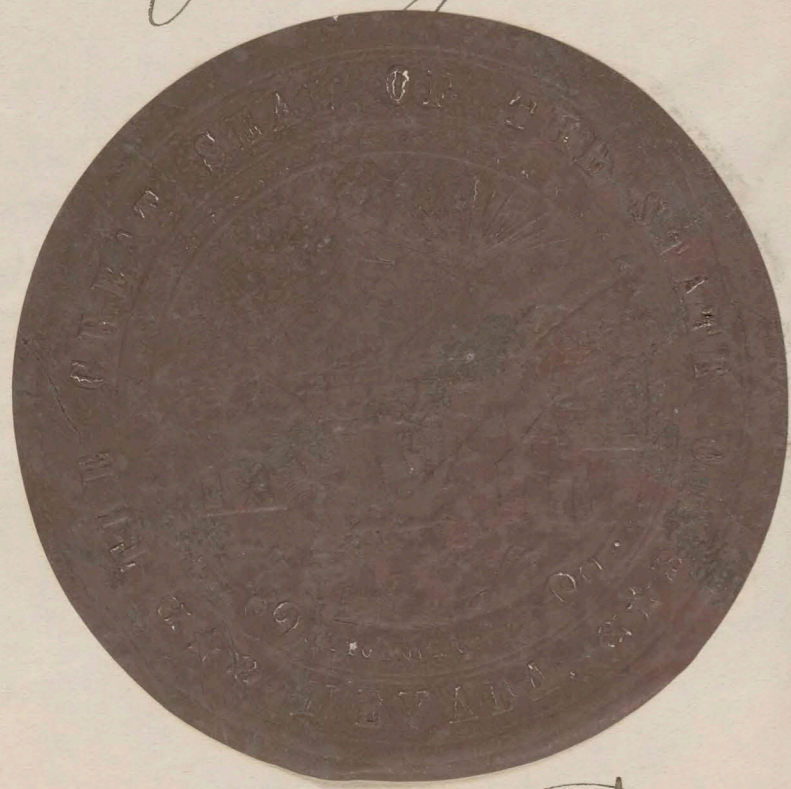
To all, to whom these Presents shall come, Greeting:

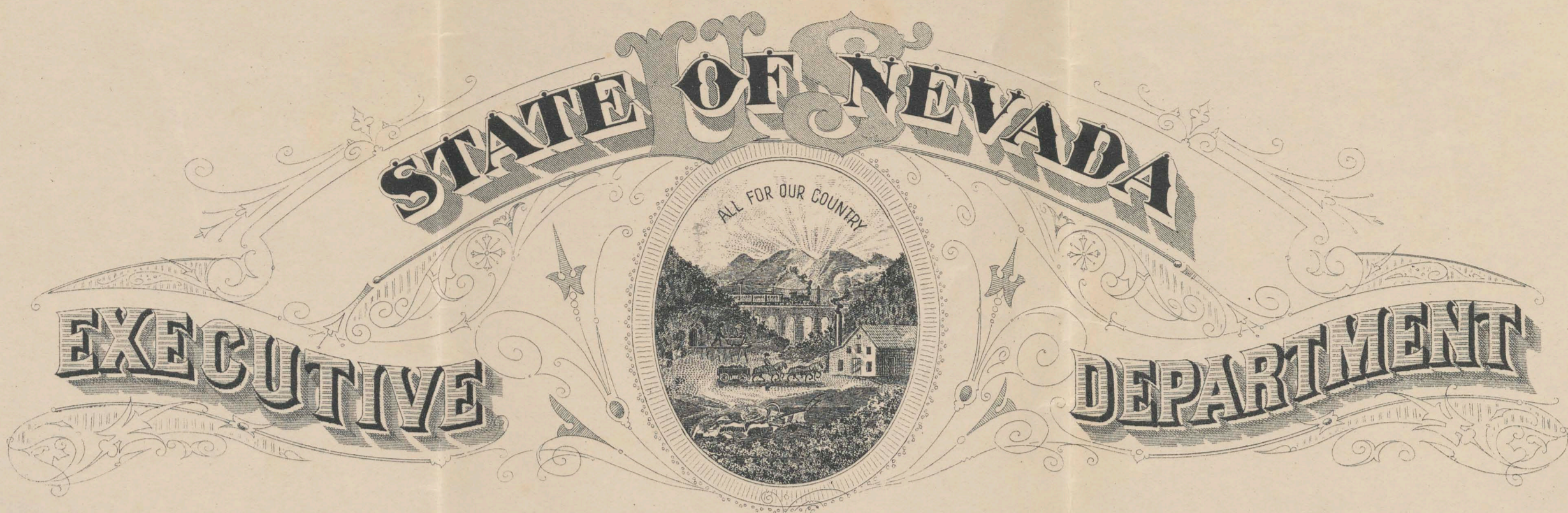
