ASUN elections are tomorrow

Voting will be for ASUN President, Vice-president of Activities, Vice-president of Finance and Publications, and College Senators.

A current student body card is required.

Polls will be located at Student Union, Library, Education Building (Upstairs), Mack Social Science, Fleischmann Agriculture, Medical Science Building, Ross Business, and the Dining Commons.

Elections give me a headache! There are enough rumors going around to burn out a professional gossip's overload fuse. And skullduggery abounds, just ask any candidate (if you've got an hour or two).

A few people are concerned about one factor, the control of the incumbent government over the election process. Some candidates feel the election board is paying more attention to the conduct of their campaigns than others who happen to be friends of the current administration (i.e. Mayer et-al).

I feel this could be a serious question. Election Board Chairperson Donald Dakin was appointed by incumbent President Tom Mayer. Because Mayer is running for re-election, it is exceptionally important that Dakin run a clean shop. Even minor inconsistencies could become major issues under the current situation. I know of at least one campaign manager who has sought legal advice on the chance it may be necessary to seek a court injunction to invalidate the election.

Such a step would be valid. Since the ASUN constitution was accepted by the Board of Regents, the ASUN stands as a state agency and is subject to all state laws.

On the local scene, a challenge has been filed against the primary election. The student who filed the complaint alleges five violations of the ASUN constitution, election by-laws or general candidate rights. These allegations include a claim that signature books were left open during the primary voting and that candidates could see who voted, that having Candidate's Night after the primary violated each candidate's right to equal campaign opportunities and that having the polling booth in the student union moved people to subconsciously vote for the incumbent and better known candidates.

Heide Robken-Balzar, chief justice of the Student Judicial Council, said the council will consider the challenge today. According to Robken-Balzar, the council will probably not have a hearing on the matter but rather consider the complaints and render a decision.

Robken-Balzar said she had no idea what the decision of the council would be. The council can throw the election out if they decide serious violations have occurred, but I doubt they will in this case. Of course, it would be interesting. Then everyone would have to start all over again.

Data from previous elections seems to be the focus of another issue. I noted in Friday's column that records from previous elections are available and might be a source of valuable information for this year's candidates. One candidate claims he has since been denied access to this data—which, by the way, must be kept as public record.

Election Board chairperson Dakin said he has had no recent requests for data from

previous elections, but that some have asked to see the registrar books from the primary. These records, Dakin said, he intends to keep confidential until three weeks after the elections are over.

The only persons that have checked past records, Dakin said, were representatives of certain sororities which require their members to vote.

Whatever the truth of the matter, one fact is becoming clear—election records should be kept in a clear and concise manner, as specified by law. One would think that our junior politicians would realize that election data is important and should be carefully kept, but

then the ASUN never has shown a great deal of foresight. In any case, the senate should deal with the issue now and establish set procedures for maintaining all election data.

I was off in my estimate of voter turnout last Friday by three per cent. The registrar's office includes graduate students, who are not eligible to vote in ASUN elections, in their listings for regularly enrolled students. Since I used the total figure for regularly enrolled students, my percentages were slightly off. The actual voter turnout was a whopping 15 per cent.

Editor:

If you are one of approximately 210 graduate assistants and fellows at this university, you have been given the right to enter into a collective bargaining agreement with the administration. This action was finalized by the passage of Chancellor Humphrey's resolution 74-2 at the February 21 regents' meeting.

Subsequent to the approval of our right to bargain collectively, several interested graduate fellows and assistants met to discuss the possibility of forming a professional organization comprised of assistants, fellows and those individuals interested in becoming an assistant or fellow. We hope to form an organization separate of GSA (Graduate Student Association) since we feel as employes of the university we have separate and distinct responsibilities and interests apart from graduate students. We feel as employes we need a means to officially communicate with faculty and administration concerning our wages, hours and conditions of employment.

At the present we feel our goal should be to form an organization and from here we can determine the course we wish to take, whether it be to enter into the process of collective bargaining or to find another means to communicate with the administration. We need your opinion now on this issue.

The steering committee to help form an organization has scheduled a meeting for Tuesday, March 18 in the East-West Room of the Jot Travis Union for all interested persons. We wish to discuss the following:

- 1) The possibility of forming a professional organization for graduate students and fellows.
 - 2) Do we have employment problems?
- 3) What does the right to bargain collectively mean? Do we wish to enter into a collective bargaining agreement?
 - 4) What alternatives are available?
 - 5) If we do decide to bargain collectively, do we wish to join a faculty organization?
 - 6) Proposed legislation in Carson City.

Please attend the meeting March 18, Tuesday, in the East-West Room of the Student Union.



Pat Archer



Biography:

In a recent editorial in the Nevada State Journal it was pointed out that I have been involved in student government for most of my life. In my second semester at UNR I became involved in government. I was appointed to the Intercollegiate Athletics Board and the University-Community Relations Board. In March of 1973, I was elected Education Senator, and in April of 1973, I was appointed to the Centennial Committee and later named chairman of the Student Activities sub-committee. In 1974, I was elected ASUN President and have served on all ASUN boards and committees.

Statement:

In the past week I have talked with many students and the question I am most often asked is, "why do you want to run again?" My primary reason for running is to give ASUN the advantage of continuity. The administration of UNR can calculate to the day when a new president comes into office, and they do. In October, 1973, an issue arose which was called Contracting Authority, which meant the Chancellor wanted the UNR president to sign all ASUN contracts for not only legal checks but fiscal checks as well. The ASUN fought this issue from October to April when it was supposed to be finally decided, instead it was put off until the new student body presidents were sworn in. Fortunately the ASUN came out alright. This should serve as a recent and critical example of the advantage the administration has over the students.

If I am re-elected the administration will not have this advantage for the first time in the history of student government on this campus. Also now is a very important time to have this advantage of continuity because:

1) ASUN has made more progress this year than in all other years combined in taking steps to upgrade dormitory living; this must be continued because we now have a degree of momentum which may be lost in a transition

2) I am currently working to achieve a student regent which would greatly strengthen the student position on campus.

3) I believe students should have more to say in the area of the spending of their Capital Improvement fees which each student pays \$84a year for and has no say as to where it goes.

4) ASUN must work with several departments in Arts and Science to establish a new college which will be more flexible in curriculum.

5) Next year will be a hard year financially for ASUN because I have not asked for an increase in ASUN fees; therefore it is important to have an executive officer who is familiar with the budget.

In conclusion there is a definite difference between Pat Archer and myself; it's not just experience but the comparison of accomplishments and past performance as well. I hope you will consider the difference between candidates and what each candidate has to offer, and consider the advantages of continuity in your own mind. There is a lot of be gained, and now the choice is yours.

—Chairperson-Student Service Committee of the Senate.


—President-Student National Education Association.

Black Outlook

Black at UNR can be lonely frustrating, full of hassles and isolation.

Several black students described their experiences at UNR. Because they fear retribution, their names have been withheld.

One student said, "If you are outspoken, you're branded as a troublemaker. You're labeled and it's hard to overcome that label and all the trouble it brings."

The students talked about the eerie isolationalism the only black in a class feels. Sometimes there are two blacks in a class but rarely more. Because of this uniqueness, different demands are placed on them.

Joe said, "Sometimes you get a professor that wants you to think he's really a liberal. They make the blacks appear to look to be real cool and look at you the whole time they're saying it. It's like saying 'Hey, I even have one for a friend.' Any time they push a liberal point of view they stare directly at you."

This is one of the better student-professor relationship type problems. A far more serious one is where the student continually must prove his worth.

Sam said, "Some of the professors look right over me, like I don't have anything to offer. It's not true, I do have something to offer. Or they'll tell you to look at things with a different perspective. Everyone looks at things with their own perspectives. I can't look any other way."

They all said that in many classes the work they do has to be far more superior than the white counterpart's. They said their work has to be very good for it to be accepted as worthwhile

Angie said, "Your work is the best, if it's not only the best but by far the best. It has to be above standard. Some professors have the attitude that a black person is not capable of making A's."

The students think the foreign language requirement is unfair to the black students and the reason why many of them don't graduate. The requirement is especially difficult to them, they said, because many of the students do not have the proper background in English.

Here there is just blatant racism

Sam said, "Many black students are having trouble with English. They don't have a very schooled background in English so trying to learn a foreign language is almost impossible. Instead of having that requirement, they should offer more requirements in English. That would be more beneficial to them."

Co-operation with the black students by the administration is almost non-existent, said the students. They cited the fact that there are few black professors at the university and no more are expected to be hired for a while.

Another trouble they say they have is in the form of monetary assistance. They said many blacks qualify for loans but few qualify for grants. This means they run up large debts in order to complete their education.

They do not feel that student government is responsive to their needs. They said the trouble first started in 1971 when the Black Student Union (BSU) staged a protest in the student union.

They said since the demonstration they have had trouble with student government support for their activities. They cited a recent request, turned down by the student senate, for a dance and a banquet. The senate said the event had been planned for a poor time.

Sam said, "We took a lot of shit on our request and then they turned around and gave the money to a fraternity for a beer bust. On our request they made us go into real detail on exactly where every penny was going to be spent. They didn't ask as much from the fraternity but they made sure they knew where every one of our coins was going. Vote for what? Student politics is a joke. They don't do shit for the black student."

The student had complaints against the athletic department too. They said many blacks are promised things they never get or hardly play. Coach Jack Cook of the track team was singled out for praise in his handling of his team members.

Sam said, "The only way they let a black student play is if they need you bad enough to make them look good. They really aren't interested in letting you play. The bad thing is that the university sets the tempo for all the high schools in Nevada so this attitude carries over."



There are some troubles with non-black students too but not as many. One thing that really irritates the blacks are some of the jokes told by the students.

Joe said, "These are jokes that aren't funny if you're a black person. The jokes about boys and suntans are especially irritating. They're just not funny."

Angie said, "But you can't react to the jokes. It's a waste of time. If you're outspoken you're labeled as a militant."

Another irritation is the student who wants to go out with a black just because he's black. The student thinks it would be cool and show how liberal they are. On the reverse, it is the turndown on a date just because they're black.

On the whole, blacks do not seem to be happy in the UNR atmosphere. They cite the fact that many blacks go elsewhere or transfer and thus don't graduate from here.

Sam said, "This university has a history of long term racism. What does it offer besides four more years of hassle? Nothing. I'd almost tell a black student to go to the University of Mississippi or to Brigham Young University because at least there you expect to find racism. They try to compensate for it. Here there is just blatant racism."

They advise young black students to evaluate other campuses before selecting Nevada. They said the student would probably be happier somewhere else.

Angie concluded, "On this campus if you show any semblence of racial pride, you're blacklisted and blackballed and all you can expect is four years of hell."

If I seem free, it's because I'm always running.



Jesse Colin Young has been a part of the music scene in America for over a decade. He is best known as the lead singer, bass-guitarist of the Youngbloods—a group he formed and gave distinction through his songwriting and unique voice, which has many times been called one of the best in rock music today.

The Youngbloods received national recognition in 1968 when "Get Together," a song from their first album, was used for a commercial and became No. 1 on the charts. During the time they were together, the Youngbloods released three albums on RCA and four on their own label, Raccoon Records.

When the Youngbloods disbanded in the spring of 1972, Jesse put together a back-up band with some of the musicians who appeared on his album "Together." The album was released that same spring, and was Jesse's first solo release since the group's formation.

Soon thereafter, Jesse began playing club and concert dates throughout the country and produced his second solo album, "Song for Juli." He draws from a wide range of musical forms and has the ability to execute a hard rocking rhythm and blues number, a country tune, or sophisticated jazz ballad.

Can you speed?

In a novel policy, San Jose police chief Robert Murphy announced that instead of being arrested and jailed, some pot smokers would instead receive a citation similar to a traffic summons, requiring them to report to police headquarters within seven days for "informal booking." They would, however, still be subject to trial.

All her fault

Divorces in the U.S. continued their 12-year upward movement, totaling 970,000'last year, an increase of 6.2 per cent over 1973. At the same time, the National Center for Health Statistics reported both the total number of marriages and the marriage rate decreased for the first time since 1953.

Age before booty

In its fourth report on nursing homes, a special subcommittee of the Special Committee on Aging, declared too many doctors were treating elderly patients by telephone. Thus between 20 and 50 per cent of medications given in nursing homes, it said, were in error.

Liable to sue

A lecturer at UNR doesn't think Nevada legislators will follow Wisconsin's lead in requiring all liability insurers to participate in a medical malpractice insurance pool.

Terrie E. Troxel, director of the Statewide Program for Insurance Education, said Wisconsin's bill was the first of its type in the nation. He said the California Legislature is studying a similar measure.

Malpractice insurance came into focus in Nevada in January when Argonaut Insurance Co., the prime insurer for the state's doctors, announced it was withdrawing from the medical malpractice insurance field.

Troxel critized Wisconsin's action because it forces companies who have never written malpractice insurance

to participate in the risk-sharing pool.

The problem is being studied by a special joint legislative committee, headed by Sen. Norman "Ty" Hilbrecht, D-Las Vegas, and recommendations are expected from the committee by April 1.

Students may think twice before they drop classes in the future, said Jack Shirley, Director of Admissions and Records at UNR.

A new method of assessing student fees, which will begin with the fall semester, requires that students be charged for the number of credits they are carrying rather than paying a consolidated fee.

"The new fee schedule will be a more equitable system for the students," Shirley said. "At the present time, a person carrying 12 credits pays the same as one carrying 21 credits."

Students with 12 credits a semester will have an eight per cent decrease in their tuition fees, but those carrying an 18-credit load can expect approximately a 28 per cent increase.

"Students with economic problems may not be as likely to register for a large number of credits," Shirley said.



For those of you who were not lucky enough to get tickets to last weekend's Jazz Festival, I apologize. I was led to believe that UNR students would be able to attend the function, especially the evening performance. Why this event could not have been held in the Centennial Coliseum is beyond my comprehension. When you get right down to it, the acoustics in the Coliseum are just as good if not better than those of the Pioneer Auditorium. And at least the people of Reno as well as the students of this university would have been able to see and hear the fantastic bands that were on display for the three days of the festival. I think we all owe a great deal of thanks to the tireless efforts of the KUNR crew, engineers, director, and especially to the D.J.'s. To Dangerous Dan, Big John, Lovely Vicki and all the other D.J.'s whose names I couldn't get: Thank you for bringing us such wonderfully complete minute by minute coverage of the Fourteenth Annual Reno International Jazz Festival. There are many of us who are grateful to you for taking us backstage and letting us in on the festival. Kudos to you all. And of course I must say thank you to Mr. Wendel Dodds, director of KUNR, for making it all possible. Everyone did a won-

After viewing the festival from all angles, I have to tell you that I was never more impressed with a group of musicians in my life. There were so many bands and combos I liked, that to choose one over the other for a review is difficult. What I am going to do is give the highlights of the festival as I saw them and give you my choice as to what were the best bands.

For my money there were two high school bands and one elementary school band which stole the entire festival away from their contemporaries. The best performances on the high school level were given by the Iolani High School Ensemble from Hawaii and the Lincoln High School Jazz Rock Ensemble from Lincoln, California.

The Iolani High School Jazz Ensemble was nothing short of superb in their execution of such numbers as: Bassie, Straight Ahead, by Sammy Nestico; Spinning Wheel, arranged by Adrian Drover; and Thel's Tune, by David Baptist. Then there was what I have to call the best Jazz-solo on trumpet of the entire festival. That solo was turned in by a little "Lady," with the lung power and verve of a Dizzy Gillespie, by the name of Chantal Spoor from Lincoln, California. Playing their version of Hey Jude, by Lennon and McCartney, the Lincoln High School Jazz Ensemble backed Ms. Spoor in her display of dazzling trumpet virtuosity.



The college bands were given a run for their money by these bands, especially by Washoe County's own high school bands. One gentleman, Jay Lawrence of Sparks High School, brought accolades of "Another Gene Krupa" from many critics for his fantastically executed drum solo, while the Reno High School band wowed the audience with their rendition of Gershwin's "Rhapsody in Blue."

The only really sad and shameful episode of the entire festival must be rightly laid at the feet of Mr. John Carrico Jr. for his totally unethical and barbaric closing of the curtain on the superb San Diego State University Jazz Band. Even if by the grace of the stopwatch they had been over their time limit, it was wrong to close the curtain on a band that had only gotten a quarter of the way through their last number. In this reporter's opinion, Mr. Carrico Jr. used the poorest of judgment in his action and his display of arrogance afterwards certainly didn't help matters any more than he'd already hurt them. I should hope that next year Dr. John Carrico Sr. will have sense enough to appoint someone other than his immediate family to run things backstage at the festival. Either that or bring back Mr. Gene Isaeff to help run things. I heard grave rumblings from many directors and the audience about this affair.

The only other incident to mar the festival was the tasteless performance put on by the San Jose State Jazz Band. What started out as an interesting protest ended up as a mockery of the protestees themselves, who are actually able to play comprehensible charts when they aren't making asses out of themselves. If they had cut the protest (which according to their director was an expression of what they thought of the festival) off at the recording of the "toilet flushing," it would have been most effective. However, they didn't and for fifty-five minutes we were accosted by some of the worst effects in music (if you could call it that) I have ever had the misfortune to experience in my life.

All in all it was a most rewarding experience for those of us who either saw or heard the festival. We can be especially proud of our own UNR Jazz Band, who were chosen to play Saturday night with Larry Londin and Maurice Anderson, the number one steel guitarist in the jazz field today. Their rendition of the Lennon and McCartney song "Norweigan Wood" plus their work with the two professionals is proof of their title as one of the three top rated collegiate jazz bands in the country today.

With the closing of the Reno International Jazz Festival Saturday night, we marked the count down to the festival's phase two part which is scheduled to begin on April 4 of this year and to last for two days. Phase II will have its emphasis on vocal jazz and should prove as interestingly diversified as Phase I. I certainly hope that by then or next year we will be able to have seats in the festival, because it seems to me that the host town should at least get a chance to view the bands as well as hear them.



Jessie Colin Young: Songbird 1975 Warner Brothers Records: BS 2645 0698

Talk about coincidence! This album caught me by surprise this past Friday, just six days before the Jessie Colin Young concert which is tomorrow night. I know I'm starting to sound like a broken record, but once again here is an album that I cannot find any fault with.

You say you like plenty of horn work in your music, Songbird has it! You say you like: Rock, Blues, Country, or Jazz (choose one of each or all catagories)? Songbird has it! You say you like to hear good keyboard work in your music? Songbird has it! You say . . ., well I guess you get my point by now. In fact, when you get right down to it, Jessie Colin Young has gathered to him one of the (if not the best) most mature and tight sounding bands in this country today. Formed in the spring of '72, and backing him up on his "Together" album, the band has progressed along with Jessie on his other two previous albums to Songbird: Jessie Colin Young-Song For Julie, and Jessie Colin Young-Light Shine. To date there can be no argument as to the staying power this combination will have in the future.

The music on this album is an example of what musicians in the "so called" Pop-Rock field can put out. You know by the third song that Jessie and the band actually love what they're doing, and that they respect and feel their music to the point of caring about the quality it must possess, before it goes on a track. That's why it's hard for me to pick out tracks for critical comment. There are nine great tracks on Songbird, and each one could be a hit. Yet my favorite tracks have got to be: Songbird (the title track), Daniel (one of the best jazz-rock compositions to come out so far this year), and 'Til You Come Back Home (it will be interesting to see how many versions of this one we will hear coming out of Nashville this year. Ann Murray is my candidate to sing this one and make it a hit in the country-western field). There is one other song I would like to point out for those of you who are into playing the guitar, especially in the Folk-Music-Bluegrass field. That song is Sugar Babe, and if you want to have some fun playing a tune this is the one to learn.

The three songs I choose for this review are the best examples of the versatility of Jessie Colin Young. Songbird, the album's title track, is a bossa-nova jazz ballad in the style Jessie has shown us on his previous albums. It is light and airy with the right touch of flute in the back-up and with an orchestration that shows his good taste in musical instrumentation. The lyrics are of course all Jessie Colin Young and don't give you anything else but pleasure in listening to them. Along with Jessie's great vocal work (has it ever occurred to you that men with good voices, who write-sing sensitive lyrics, are labeled by many as "sickening sweet" and don't get very much attention as far as the charts and concert attendance is concerned? Yet men with the most horrendous voices are right up there at the top of the charts and get all the attention. Why is that, I wonder? Any comments from music fans out there?) there is real quality keyboard work by Scott Lawrence at the piano on Daniel. Then again I am more than impressed with the horns on this track. Tight! That's the word for the way Jim Rothermel (flute, saxophone and clarinet), Ron Stallings (tenorsaxophone), and Peter Welker (trumpet), play on Daniel. Much thanks for the horn arrangement must of course go to Ted Ashford, who is to be complimented for his ability to balance it all out. Jeff Myer (drums and percussion) and Kelly Bryan (bass) are masters on their respective instruments, lending to Daniel as well as the rest of the tracks the added subtle strength that only true musicians can put into music. Daniel possesses that mystical quality which will always differentiate a hit from the commonplace tune. It's hard to put your finger on what it is you like about a song or tune, but Daniel seems to have all the qualifications needed. There is a readable melody that 15 Superior to many others, it is well orchestrated, with a rhythm that grabs you right from the first note and keeps you going long after it has ended. And that is also what you will find inthetrack titled, 'Til You Come Back Home. This track has got to be one of the truly great country tunes to come out in a long time. It isn't obtrusive like many country tunes are today and the lyrics are as mature as anything else written, and especially sensitive and easy to listen to.

Songbird will no doubt be one of the top albums of the year and may well prove to be the album to finally put to rest any doubts you may have had about Jesse Colin Young. I know you all enjoyed the Loggins and Messina concert last fall immensely, and I promise you that you will enjoy the Jesse Colin Young concert tomorrow night equally if not more. Jessie has a fine voice and style to equal anyone else's and his music is versatile as well as diversified. If you are not sure about Jessie Colin Young, Songbird will make you sure.

For a real good time and some really fine music, I recommend Jessie Colin Young: Songbird, as the album to get. Settle back with whatever makes you happy and listen to it. You're going to thank yourself for having such good taste. Songbird is really a mocking bird in disguise.

Circle Notes: Speaking of Jessie Colin Young, I was shocked to read in the 'Brush last week that Pete Perriera reported a sale of only 327 tickets to the concert tomorrow night. I am not only shocked to know this, but I am appalled to see such a lack of interest in a talent whose concert should have been sold out weeks ago. What really ticks me off is the bitching I hear on this campus about the shit concerts the ASUN brings to this town. I for one feel the ASUN has gone out of its way to bring some really excellent music to Reno and the University of Nevada. If you would stop your bitching and go to these concerts you may find out that you've been missing some great music. I hope by the time you read this, that ticket sales have gone up. It would be a shame to miss Jesse Colin Young at his best.

I was saddened to learn today that Flora Purim was not absent from Keystone Korner Berkeley last fall because of hospitalization but because the Supreme Court refused to review her 1971 conviction for possession of cocaine with intent to sell. She had actually entered federal prison at the time to begin serving a three to five year term. The music world will miss her!

In the "Strange But True, Eeyuch" department, here's an item that is guaranteed to either turn your stomach, or convulse you with laughter. (If you have the flu I advise you not to read this.) David Cassidy's new girl friend is John Lennon's estranged wife Yoko Ono. They claim it is not the usual love affair, but rather an intellectual romance, as they only appear in museums and art galleries together. Whatever turns you on, I guess!

That is all for today. This Friday, hopefully, I will have an interview with Jessie Colin Young and a review of the concert.

There ya' go! Listen To The Music!






