

Editorial

This editorial is unique for the student community in that it is a break from tradition. Normally, in past years the Sagebrush has refrained from taking sides in student elections.

Past editors were generally of the opinion that to present opposition or support for particular candidates was unfair to the majority of the students, not the candidates. It was felt that with only one campus newspaper students would have difficulty in choosing who they should vote for.

Instead, particular candidates were endorsed by Sagebrush columnists or staff writers, with space provided for guest opinions of opposing views.

Yet in the vast majority of election races, it was fairly well assumed that there were at least two qualified candidates running.

This year at UNR has also been unique. To most of us it has been a question of how could so many things go wrong in so short a time. Not only have three of our numbers been lost in senseless deaths, but ASUN has been plagued with in-house fighting and, in several cases, ineptitude.

Because of the unusual nature of 1975-76, we at the Sagebrush feel that two of the candidates that are seeking executive positions are simply not qualified to take over the government, whatever their past accomplishments have been.

Jack Reinhardt is seeking the presidency of ASUN. He has served for the last year as V.P. of Finance and Publications, during which time he has developed a nasty habit of making editors tear their hair and eat their pencils.

Reinhardt was helpful in convincing the senate of the Sagebrush's plan to invest \$10,000 to save \$12,000 a year in printing costs. He was personable and appeared helpful.

But when the pressure came on, the problems started.

The Artemisia/Sundowner photo controversy was rough on everyone involved. Feelings and emotions on both sides were considerably strained. Yet, since we are for the most part stable people, we acted like adults in our relationships.

However, we feel Reinhardt was, in many cases, lacking in the maturity necessary to represent 8,000 students in an official capacity. The height of this was when Reinhardt simply walked out of a later Publications Board meeting after refusing to answer Artemisia editor, Bob Horn's, questions about the state of his discretionary fund. Whether the questions were valid or not is no excuse for behavior like that.

Reinhardt's unprofessional conduct has made his dealings with Publications and others difficult, if not impossible. During the Artemisia problems, Reinhardt refused to comment or make his position clear many times. This not only made communication next to impossible, but made our task of providing both sides of the issue difficult.

Reinhardt is being opposed by a newcomer, Jim Stone. Though Stone is untried in ASUN government, he has shown us a concern for making the upcoming year something

far better than this one has been. His newness to the scene of campus politics is probably his greatest attribute. His record is clean.

For us, these two represent opposites - A legacy of disagreement and uncertainty against a hopeful unknown.

The other race in which we have decided to make our position known is that of the V. P. of Finance and Publications in which Marc Cardinalli is opposed by Senate President Pawl Hollis.

Hollis has served the College of Agriculture well in the past two years as their senator. However, his involvement in student government this year has been a poor example of leadership as head of the student's legislative body.

After his involvement in the tragic death of John Davies, Hollis' attempts to run an unbiased senate failed miserably. This is evident by the record-setting number of times he passed his gavel (stepped down as Senate President to express his opinion) and the senate's subsequent attempt to abridge the freedom to portray an actual event.

Hollis' actions in front of the Board of Regents has also made us question his ability to provide competent student leadership. Finally, we must question Hollis' motives towards free press based on his record.

Cardinalli, on the other hand, has proved time and again his concern for the betterment of this campus. Not only does he support the free exchange of information, but he has been involved in the workings of both the press and the government in his part in establishing an ASUN Investigative Office. Though he has been vocal on several issues, he has at least been professional and courteous. Cardinalli has shown those that know him his ability to deal rationally in the day to day workings of student government.

In both of these races we feel there is a serious question of qualification. Not only have Reinhardt and Hollis shown a lack of maturity and leadership, but their records have proven their inability to represent the students adequately.

We have provided the candidates every opportunity to express their platforms and reply to our position. Our desire to stay out of elections as much as possible, is evident in our lack of commentary on the other races. In the case of the V. P. of Activities, we feel that both candidates are competent and both could do a good job of representing the student's interests.

Hopefully, as many people as possible will vote tomorrow. The polls will be open all day long in the Travis Union. But, when you vote, consider the possibility of another year of headaches and hassles, or the promise of some constructive advancements in the students rights, and more importantly, pride.

After all, you have to do it. We can't do it for you.




ISSUES: Students have waged a long and hard struggle to procure the rights which should be theirs without question. Students have the right to decent living accommodations in the dormitories. We need to go to the Board of Regents and get the money we need to make them fit to live in. We have the right to decent food in the Dining Commons. These people signed a contract to feed us properly. They are obviously not living up to their part of the bargain, therefore we should have the contract reviewed by our attorney and revoked if possible. Then we can hire someone who will feed us properly. I pledge myself and my administration to work diligently on these continuing problems, because the students of this university have the RIGHT to the minimum comforts of life.

ASUN President Pat Archer has made significant progress on the Foreign Language requirement this past year. The Arts and Science Goals committee passed a resolution two weeks ago that will make the requirement optional with some departments. While the resolution must still be approved by the Faculty Senate, it is the first major breakthrough we have been able to make on this issue. I pledge myself to continue Pat's efforts in this area.

I have been amazed at the need that students on this campus have for legal assistance. I have been equally amazed that there has been no action taken to provide the students with this much-needed service. I propose to establish a legal counseling service whereby students may get FREE legal assistance when they need it. There are two ways we can establish this program. I propose to look closely at both and establish the one which will best serve the interests and needs of the student body.

Plan one would look to the legal community in Reno to donate their time to the students. This would accomplish two things: 1. It would be helpful in improving student-community relations. 2. It would provide us with the legal assistance we need. Plan two would call for ASUN filing an application with VISTA for two full time attorneys to be assigned to ASUN for the exclusive use of the student body.

Finally, I have heard it said that students are tired of an unresponsive student government. If you are one of these students, then I urge you to vote for JIM STONE for ASUN President. I cannot cure all of the problems we face on this campus in one year, but I will bring new vigor to the office, and I will work for you, the students. Protect your rights. Elect JIM STONE ASUN President on March 17th.



Jack Reinhardt

My name is Mark Tuffo, and I am running for Vicepresident of Activities. I am a native Nevadan and have attended UNR since Fall of 1972. I am majoring in Electronics Engineering Technology.

I am pursuing this office because I feel that the transcription students have been socially deprived. For the most part the activities of the past have been non-representative of their interests. During the past year there have been two specific areas of activities that have suffered greatly at the hands of the current Vice-president and the members of the Activities Board. These areas are concerts and guest lecturers.

If elected, I will institute the following changes in

those areas:

1. I will make myself accessible to all students by establishing open office hours during which time they may come in and express their independent or groups' activity interests.

2. Prior to each Tuesday's Sagebrush, I will submit for publication an agenda of business to be discussed at Wednesday's Activities Board Meeting so that interested

students may attend.

3. I want to require the concert promoter/producer to put up a bond equal to the dollar amount of tickets sold to ensure immediate refunds in case of a "no show" concert or lecturer. This would also apply if there were a change in the performer and/or cancellation of the performer. At the present time the ASUN Concert Policy states that the producer must publicize refunds for a minimum of only three weeks after the cancellation of the performance. I want to see this changed. THE STUDENTS ARE ENTITLED TO IMMEDIATE REFUNDS!

I want to emphasize that in the area of contracted events I would deal only with reputable promoters. I would not tolerate promoters who produce "no show" events such as the Ohio Players concert.

I want to maintain a diversified activity schedule in-

cluding Rock, Jazz, Folk, and Country and Western Concerts, provocative guest lecturers, dances, plus traditional university functions and increased new activities.

I have talked to different students who have express-

I have talked to different students who have expressed interest in obtaining top name entertainment such as Earth, Wind, and Fire, Allman Bros., Crusaders, Waylon Jennings, Masters and Johnson and Ralph Nadar, just to name a few. I would do my best to follow through on these requests.

I feel that I have the requirements to be Vice-president of Activities. I have the ability to deal with promoters, board members and students. I am especially knowledgeable in the field of music. Most important, I would be representative of the students' interests.

I would appreciate your vote, and, in turn, I will put enlightenment and excitement into your activities.

Marc Cardinalli

My qualifications for the job of VP of Finance and Publications include being editor of two high school newspapers and assistant editor of my high school year-book. In college, I was assistant and managing editor of the Guardian—paper of the City College of San Francisco. I am a journalism major at UNR, actively involved with the Freedom of Information committee in that department. I am the student representative on the Arts and Science Finance and Scholarship Board which allocates funds to students.

The office of VP of Finance and Publications should and will be objective and fair. No single student or organization will have the final say on any issue. Every opinion will be carefully considered before any issue is resolved.

The Finance Control Board will distribute funds to organizations according to need, type of activity and number of students in that organization. A written budget will be required before and after funding with all unspent money returned to ASUN. Every dollar allocated to the Finance Board will be distributed properly and fairly. All students coming up before the Board for funding will be treated equally, impartially and fairly. Funding will not be refused without probable cause.

The rights of the editors to control their publications and the integrity of the publications will be strictly adhered to by my office and the Publications Board with no interference from either. The budgets for the various publications will not be cut in any way be my office, and, if possible, will be increased to help expansion. Appointment of editors and business managers will be based on ability and experience.

My platform consists of 8 basic points which I feel deal effectively with the issues facing the VP of Finance and Publications:

1. A weekly column should appear in the Sagebrush telling students where their money is going. This includes money given to organizations, publications and funds spent by student government.

2. I will attempt to establish a student run publication that will review all professors and classes on campus.

3. I will hold regular meetings with publications personnel to insure maximum efficiency and discuss such topics as funding and expansion.

4. Several Publications Board meetings will be held in the Artemisia and Sagebrush offices to acquaint Board members with the mechanics of publication.

5. An advisory board will be created to help students find help with financial and legal problems.
6. A review of the desirability and effectiveness of the student insurance program and Heath Services funding will be instituted.

7. An intensified public relations program will be established to help Reno and Nevada become better acquainted with the students.

8. A re-evaluation of student funding priorities will be instituted along with a program to cut the fat from the budget so more students and organizations can get more funding.

Since the Sagebrush is the only source of media on campus, we are offering this opportunity for your response. No responses will be accepted after 6:00 p. m. Sunday. -Bob Anderson

The first point that I don't understand is the fact that how is it possible for a candidate to write a reply to the March 16th Sagebrush's opposition when he has no idea what is going to be written? Next, is it the editor's prerogative to allow Sagebrush staff members to review, analyse and then write articles from material submitted by candidates or any one else by the established deadline? According to responsible journalism it's, may I use one of your favorite words, UNETHICAL. The editor has already assured me that it is his prerogative to allow this and that it has been done all year long.

In the past, editors like Kelsie Harder chose to commend specific candidates for outstanding qualities, but refrained from using undue criticism so not to unfairly distort public opinion.

I secured the monies, much more than in past years, for all publications, and worked to get the ten thousand dollars worth of Sagebrush equipment this year. It's evident that my active support means nothing.

Under these policies of this years' editor, pertaining to student elections, it's impossible for anyone in political office to express himself freely during a school year. What this means is that any person in office having political aspirations for another office or term has to serve his term under threatening conditions and restrictions. I was saddened to read in last week's Sagebrush that students involved in campus politics are not more supportive and understanding of each other's individual efforts and viewpoints.

Many things were brought up last week by Paul Gallo in his column that need to be cleared up.

The death of John and close call of Gary has been the most tragic event of my life, and in my heart, I still regret it very much. It was not only the event itself, but the actions which followed that concern me.

When the Artemisia layout of John's memorial and the Sundowners were put together, there was a great

deal of controversy. This led to Senate action and length Publications Board meetings, in which people involved were sidetracked with personal differences

My elected job as Senate President is to chair meetings of senate in an unbiased manner and to insure the prope order of business. I have never, in my capacity as chair man, expressed any bias verbally or by my actions when holding the chair. I ran the meetings in proper orde That's my job. Even Editor Bob Horn agreed to this (See Quote)

When I supported the withdrawal of funds from the Artemisia, it was at a time when I could no longer se the continued threats on parents and families of Sundowners and other people involved.

I was trying to make the point clear that our student publications should carefully review what they print and be aware of what their impact would be on the readers

Editor Bob Horn agreed that the particular layout did, in fact, have implications of guilt for one particular person. In view of this, and the threats on the Sindowner's and on his family's lives, Horn saw fit to change the layout. That was his own action.

When Mr. Gallo approached me and asked for the Sundowner's support of his Guatemalan Earthquake Relief Campaign, I was, to say the least, very surprised. I wouldn't have been so surprised had he asked for my individual help, but he asked that the Sundowners rally together to support this cause.

Mr. Gallo has criticized and attacked the Sundowners as a club and individually. He saw no purpose in the dub and did not think it should be in existence. Yet he felt that they should come out of the shadows and support this campaign, thereby gaining the approval of the

There seems to be a conflict involved here. The club has degenerated to nothing more than a few close friends. faced with massive legal actions and heavy criticism. However, Mr. Gallo seems to think that this action would cause a complete reversal of public opinion.

Let us face the facts. The Sundowner club is nothing more than a memory. With the problems facing the Sundowners, it would be next to impossible to resurrect the club. The first concern, of those involved, would be toward the memory of John, and I told Gallo this.

The quote itself was taken out of context, and was made in jest. Peggy Martin, ASUN Secretary, who was present at the time, agrees that the statement was not made in a derogatory sense.

I am disappointed that Mr. Gallo has placed himself in this position of judgement. His appraisal of this situation is both inaccurate and misleading. I only hope that the voters will evaluate me with respect to my achievements and qualifications, rather than Mr. Gallo's inaccurate and biased presentation. -Pawl Hollis

Finally, we agree that we didn't talk to Tony Schueller. It was your other advisor, Harry Parsons, with whom we discussed the matter as was stated several times in the article.



I am a media freak. I read newspapers, news weeklies, all types of periodicals, watch TV (most of which is nauseating) and I go to movies. I've found that the media has grown to such an extent that there are occasions when those who report the news or offer commentary and opinion on it have become newsworthy. There have been many examples of this: Jack Anderson, Daniel Schoor of CBS, Woodward and Bernstein of the Washington Post, and Sy Hersh (who uncovered the Mylai Massacre) to name a few. The interviewer is now being interviewed. The reporter's actions are being reported on by other reporters. It is a phenomenon of the time and will undoubtedly continue.

I find in my own experiences in the last week that I have been thrust into a somewhat similar situation, albeit in micro-scale. Paul Gallo, the commentator, has been censured by the ASUN Senate and the ASUN Election Board. Paul Gallo, the commentator, has

caused a fuss. He has made news.

Now there is another Paul Gallo. This one has conducted interviews, covered straight news stories. This one is a reporter. The reporter seized the opportunity and is pleased to announce that he has conducted an exclusive interview with Paul Gallo, the commentator who, by his Things To Think About column of March 9, 1976, has been skyrocketed into the highly unlikely and ever so reluctant role of . . . Paul Gallo - Newsmaker.

The Interview:

The Reporter: Firstly, Mr. Gallo, I want to thank you for your time. I understand that you categorically refuse to grant interviews with anyone. Why have you permitted me

The Newsmaker: I don't really know if I could say exactly why I am allowing you to interview me other than I feel a certain familiarity with you, a sense of recognition if you

The Reporter: The Sagebrush was censured by the ASUN Senate and the Election Board and your article was singled out as the cause for that action. How do you feel

about that?

The Newsmaker: I am amused. The ASUN Senate has already tried to censor the Artemisia and it is not impossible that they may have confused the two words. Stranger things have happened. If, however, they were aware of what censure means — to disapprove — then they have every right to do so. In fact, we all do. I disapprove of many things and I have the right to censure them. I hereby censure the ASUN Senate and Election Board for censuring me. I hereby censure the Boston Red Sox for losing the World Series. I censure the weather in Greenland . . . Keno tickets . . . bras . . . unfriendly domestic animals . . . parking meters . . . acid indigestion . . . the Sundowners . . . my creditors . . . lack of performance at stag parties . . . physical violence . . . and the state of the American ice cream cone.

The Reporter: Do you agree that, as stated in the act of censure, "The censure is not of content, but of timing, and the failure of the editor to allow for equal response time

prior to the ASUN Primary Election"?

The Newsmaker: My article was aimed at showing the readers that there is a serious decision in the election that would have a profound effect on the university. I might ask you a question here. Would I or the Sagebrush have been censured if the article were uncritical of Jack Reinhardt and Pawl Hollis? I think not, although I'm afraid we'll never know

As far as timing is concerned, I am utterly amazed that there are so many people who feel that they are entitled to equal time when a writer expresses his opinion. Were I a candidate for election, opposing the individuals in question, then there would be a strong case for equal time. I'm not a candidate, as you know. The action was naive and out of line, but not surprising when one realizes that Pawl Hollis is the President of the ASUN Senate.

The Reporter: On March 12, 1976, Sagebrush, Jack Reinhardt, a candidate for ASUN President, labeled you as "our champion of the downtrodden and the hero for social in-

justices," do you feel that is an accurate statement?

The Newsmaker: Well, I think he meant a hero for social justice, not injustice. Or then again maybe he didn't. I certainly want to thank him for the compliment of "champion of the downtrodden." But there were many others who helped out with Guatamalan relief.

The Reporter: Do you feel that your article on Hollis and Reinhardt had an effect on the outcome of the primary election?

and your March 9 article?







Chick Corea: The Leprechaun Polydor Records

1976 PD-6062

Chick Corea, who normally plays with his group Return to Forever (the group's name is taken from a Neville Potter poem of the same name), has created and produced a solo album of strength and beauty, which reflects the realm and reality of a "Leprechaun's Dream."

Corea, like McCoy Tyner, is a keyboard artist of the jazz genre. However, unlike Tyner, Corea who plays a fine acoustic piano, also makes generous use of electric piano, Honher Clavinet, Arp Odyssey, Yamaha Organ, Micromini Moog and Moog 15. In addition to these instruments, he also performs percussion on this album.

The Leprechaun is a stylistic neo-classic tale told through music by Corea. Being the central character of the tale, The Leprechaun is celebrated by the imps and little people of the woods that he calls home. His lady is a fairy queen of great beauty named "Lenore," and among his other friends and subjects (for he is indeed their leader), are pixies, sprites, and fairy minstrels.

as well as suggesting the speed with which these beings are said to move.

Of particular interest on The Leprechaun are "Reverie," a tone poem depicting The Leprechaun reflecting "long and deep", and two vocals: "Looking at the World," by Neville Potter, plus "Soft and Gentle," written by Gayle Moran. The vocals on both tracks are performed hauntingly by Ms. Moran.

"Looking at the World," is a piece in which the "...
fairy mistrels sing about the Leprechaun to all in the
woods," while "Soft and Gentle" is the fairy queen's
love song to The Leprechaun. Both melodies are enchanting, with a certain amount of pixish charm and

The album's most important track is, of course, "The Leprechaun's Dream." Here, Corea combines variations from the previous tracks with a recurring new melody throughout to give us The Leprechaun's final vision of the new world. As Ms. Moran's vocals intertwine with the melody lines of horn, strings and Corea's keyboards, the strong impression of a leprechaun describing his dream and inviting his friends to join him in his private dream world is created.

The Leprechaun is a thoroughly enjoyable and en-



In The Leprechaun's world, like that of mortal man, the inhabitants seek to find an existence closer to perfection. Although his world is one where all creatures sing and dance in peace, The Leprechaun has visions of something different. Perhaps like mortal man, he seeks serenity, or oneness with the universe, but he knows it is something different than his present reality.

Except for one or two lines describing each piece on the album, there are no linear notes. Corea allows the music to carry the tale and leaves the rest to the listener's imagination.

In all, there are nine pieces on The Leprechaun (which happens to be the magic number of 'The Little People"), arranged and orchestrated by Corea, which contains strong melodic lines intertwined with excellent variations on each theme. Corea has used his imagination by creating on each track a suggested atmosphere of total relation to each title.


On "Imp's Welcome," the album's opening track, his use of Moog and Arp Odyssey on the raga-like melody, creates for the listener a strong vision of a pointed eared imp with a sly grin trumpeting a welcome to The Leprechauns' world. "Lenore," The Leprechaun's "dance for his fairy queen," portrays an entity of beauty and grace,

chanting creation from the mind of Chick Corea. Unlike his previous releases (No Mystery, for instance) which were full of tension and power, this new creation is restrained and well thought out. There is a maturity on The Leprechaun, which for Corea is new and exciting.

Do not expect the universal explosions and cosmic fire of his previous efforts. If you do this, then the album will be a disappointment for you. If, however, you open your mind to the man's concepts; you too will become enchanted with The Leprechaun and may even find yourself doing a "Pixieland Rag."

Baseball Team Drops Doubleheader

Pitching is the name of the game in baseball and the UNR baseball team didn't get the amount it needed in a weekend three-game series.

The Pack had evened its record to 5-5 after Friday's brilliantly played 3-1-victory over the University of Pacific, but fell to 5-7 after dropping a doubleheader Saturday to the same team.

It was the first time all season UNR had made a home appearance and the weather was crisp, cool and clear Friday.

Pack pitcher Don Fisk, coming off a shutout performance in his last outing, showed that that effort was no fluke. He scattered seven hits while striking out nine bringing his record to 2-1.

Fisk was continually working himself out of tough spots. Pacific had a man on third

Saturday's doubleheader, however, was a disaster.

with one out in the fifth inning but Fisk responded with a strikeout and an infield grounder. In the seventh, he retired three batters in a row after a leadoff triple.

Although last year Fisk had the team's lowest earned run average, he had a dismal 1-7 record. This year however has changed. Pack coach Barry Mckinnon said, "He's in good shape. I've never seen him throw so good."

Reno could only manage seven hits themselves, three by third basemen Tim Riley. Riley tripled and then scored in the eighth inning to give the Pack a two run lead.

Saturday's doubleheader, however, was a disaster.

The Pack could get absolutely nothing effective out of its pitching staff as they dropped games 11-8 and 7-5.

In the opening game, UNR fell behind 7-0 as Pack starter Pat Alexander gave up five hits and five runs in three innings of work.

Track Team Breezes

Either the Wolf Pack track team is very lucky or much better than what head coach Jack Cook expected it to be, but at any rate, Nevada breezed by its second tough opposition, Big Sky contender Boise State, 85-68, Saturday in Boise.

"We were lucky they (Boise) had those two injuries, otherwise it would have gone right down to the wire," declared Cook. Two of the Broncos' starters, their top miler who beat Domingo Tibaduiza last year, and best sprinter were unable to compete.

But don't let that comment be misleading. The Pack did not just happen to win. "Our kids were really up," said Cook. "They wanted it." They showed it too, posting ten lifetime bests. Sophomore Tom Wysocki won the mile in 4:13.6, edging Tibaduiza; Mike Dagg of England ran his fastest three-mile time in three years in the United States, clocked at 14:22; and Terry Ybarra of Las Vegas placed third in the steeplechase with a lifetime best of 9:56.

Although it placed second, according to Cook the mile relay team ran its "best of the season" in 3:20. Wayne Valentic and Dale Clayton also achieved lifetime track bests for the 440 intermediate hurdles and 220, respectively. Valentic did the hurdles in 56.9 placing second, while Clayton was timed at 22.3 for the 220, placing third.

In the field events junior John Buffington and freshman Larry Moss, both graduates of Sparks High School, bettered their individual records. Buffington threw the shot put 52-2 for first place honors and the javelin 157-0 bringing up the rear of a Nevada sweep in that event. Although not his best, the two-year letterman also won the discus with a throw of 147-7, a meet record.

Moss, who also plays Wolf Pack football, had bests in the shot put (48-7½) and javelin (168-10) for third and second places. Nevada's Bjorn Koch of Sweden won the javelin event at 193-1, well below his school record, but he had a jammed disc in his back which happened earlier in the week.

Before the season started, Cook was leery of meeting his toughest two opponents, Chico and Boise, at the outset, but now after easy victories he sees the rest of the season as downhill. "I can't see anyone beating us for the rest of the year," Cook said confidently. "We'd have to have a rash of injuries first."

Wrestling Finals

The stench of sweat and bloodied noses mingled with loud cheering support filled the multi-purpose room of the recreation building last Wednesday during the finals of the intramural wrestling matches. Winning all three matches it was represented in was the Sigma Nu fraternity. Most of the other representation came heavily from the independents or the Alpha Tau Omega and Sigma Alpha Epsilon fraternities.

He jumped on the first pitch, a fastball belt high, and drove it over the center field fence.

Only two runs down, what the Pack needed now was a bullpen. They didn't get anything resembling that as Pacific scored four more times in the next three innings.

The University field is probably located in just about the windiest spot in the city. The wind, when swirling like it was Saturday, blows out towards right field making the park a definite hitters paradise.

Anything hit up in the air to right has a chance of blowing out and it has happened many times where a first baseman will call for a pop fly only to have the rightfielder gather it in.

In Saturday's doubleheader, there were five homers hit, three by Pacific and two by UNR.

In addition to Anderson's blast, Tom Jesse hit his fifth of the young season. He smashed a hanging curveball up into the wind in left that crashed up on the dirt hill back there. It was easily a 425-foot shot.

Nevada scored three runs in the final two frames but still fell short and lost 11-9.

The second game was much of the same as UNR fell behind and then tried unsuccessfully to play catch-up.

Last season's most successfull pitcher record-wise, Rich Jameson got ripped again.

Jameson, now 1-4, was mashed for 10 hits and seven earned runs in 4 2/3 innings. Pack relief pitching was better in this game as Rob Summer came in and didn't allow a thing

for the last 2 1/3 innings.

Tom Jesse had four hits in the doubleheader but other than him no other Pack player


had a real fantastic day at the plate.
