It is a unique and highly uncomfortable situation when a newspaper stops reporting the news and starts becoming part of it. It is not a role we take on with any degree of relish, but again, we have been thrust unwilling into the spotlight.

Perhaps it's a good thing.

Perhaps it will make our readers think more carefully about what they want from the paper they support with their student fees. Perhaps it will make us respond more carefully to those needs. Perhaps it will make us all examine the institutions that govern us as students and ask whether they are truly serving our needs.

Let your student officers knwo how you feel. Go to their offices and tell them. Or write them. And if you want to share your thoughts with the rest of the campus, write us. Make your decision known. And above all, make your decision.

Because if you don't you can be dead sure someone else will do your deciding for you.

UNR Student Senate Votes Not To Fire Newspaper Editor

After five hours of discussion, debate and hearing of testimony, the Student Senate of the University of charges and claimed there is a Nevada-Reno voted this morning not deliberate movement within ASUN to fire Sagebrush editor Gary Jesch. 'to get me out."

The decision came shortly before 12:30 a.m. with Jesch bursting through the doors from the closed session and shouting, "They did it! They voted down the motion.

Jesch said he thought the vote went 9-5 to fire him. A two-thirds vote of the senate - 12 of 18 members - was required in order to fire the editor.

Jesch also told several waiting Sagebrush staffers that student government plans an in depth investigation of Sagebrush operations.

Student Body President Jim Stone refused comment, saying, "I'm too angry to talk." Marc Cardinalli, finance and publications vice president, also angrily refused comment

Despite the plea of Jesch's at-torney, Gary Bullis, the Senate voted, 9-8, to close the meeting to the press and public.

Bullis asked Senate President John Gezelin to delay the closed meeting until he could obtain a court injunction, but Gezelin refused.

Then, news reporters and about 50 students and supporters of Jesch were asked to leave on the basis that the meeting was a personnel matter and confidential.

Investigation continues, editor survives vote

He did break a tie early in the evening when the senate deadlocked on whether to keep the meeting open or closed. But senator Ross Chichester changed his abstention in that vote, tipping the scales 9-8 for closing the session and thereby canceling out Gezelin's vote to open the hearing.

Reno attorney Gary Bullis, representing Jesch, objected to the closed meeting and asked for a delay while he sought a court injunction. But the senate refused and the meeting went ahead. The senators heard testimony from several persons and reviewed the minutes of the previous night's

publications board meeting before finally voting. Jesch had been charged with several breaches of con-tract and violations of "ethical journalism," including two counts of misappropriating funds, using his editorship position to solicit a plane ride with UNR boosters last fall to the UNR-INLV football game and regents' meeting in Las Vegas, and threatening Cardinalli with an editorial campaign against him. A fourth charge of refusing to correct errors of fact in news stories was dropped Wednesday nigh". Jesch admitted to the charges, but claimed he had made mistakes in judgment and wanted a second chance.

Cardinalli said the senate didn't act on the facts presented against Jesch. He added that Jesch threatened him again in front of witnesses after the senate hearing, allegedly accusing Cardinalli of abandoning his duties as publisher and threatening to take the matter to the news media.

But Cardinalli, too, denied there is any "war" between him and Jesch. "If this was a war, I would not have held the

Student government at the University of Nevada-Reno will investigate further allegations raised Wednesday night against Sagebrush newspaper editor Gary Jesch, who survived a late-night vote to oust him.

The senate of the Associated Students of the University of Nevada (ASUN) voted 9-5 this morning shortly after midnight not to fire Jesch, whose firing had been requested by the ASUN Publications Board Tuesday night.

ASUN President Jim Stone and ASUN Vice-President of Finance and Publications Marc Cardinalli both expressed disappointment today at the senate's action, which came after more than five hours of deliberation in a closed personnel session.

Jesch, meanwhile, could not be reached this morning for comment. But his jubilation was apparent early this morning when he burst through the doors from the closed senate meeting and yelled to several waiting Sagebrush staffers, "They did it! They voted down the motion."

A two-thirds vote of the senate - 12 of its 18 members was required to fire the campus newspaper editor. The final vote was nine against firing, five for firing and three abstaining. Senate President John Gezelin cannot vote except to break a tie.

"I was very disappointed in the actions of the senate," president Stone said this morning. "I felt that they had enough information to base a decision upon last night. Further investigation can only hurt Gary Jesch and the ASUN. And I just don't think we're in the job of character assassination.'

Stone denied Jesch's claims Wednesday that student government was out to get him. "I would like to make it known that all of the allegations except one came from sources outside the ASUN.'


Stone also defended the ASUN's quick action against Jesch, saying claims of "due process" and time for Jesch to prepare a defense don't apply. "If an employer (in this entire thing so low-key for so long a time."

Cardinalli said the new investigation will be carried out by the publications board, but he had no timetable or ground rules set up as of this morning. He said the board

will meet next Tuesday to decide on the scope of the probe. The senate called for the probe after hearing new cha-rges during testimony Wednesday night. Stone and Cardinalli again refused comment on the personnel session or on the new allegations, saying such matters are confidential.

Jesch, the first journalism student to edit the newspaper since 1973, has had troubles with ASUN - the official Sagebrush publishers - ever since he applied for the job last spring. The publications board picked him for the post in March 1976 but the student senate turned down the board's recommendation. Filing for the post was reopened for another week. with Jesch the only applicant. He again was selected, and the senate confirmed him. But former student president Pat Archer vetoed the decision, saying the outgoing publications board didn't have the right to choose the following year's editor. Once the new publications board took office in April, Jesch's selection was finally approved.



The newness of Herb Billups and his New Jersey sidekick seemed to exemplify the fresh, novel approach the UNR basketball program had that Fall of 1975.

The talk was that UNR was turning the corner as a program and the fact that they had recruited two freshmen from as far away as New Jersey seemed to reinforce that.

But somewhere along the line, things didn't quite work out like Billups probably dreamed they would. He was a starter the majority of last season and then started the opening game against Las Vegas this year in Jim Carey's UNR coaching debut.

As the season wore on, he saw less and less action. Meanwhile, Edgar Jones, the guy Billups had traveled West with, was becoming a star in his own right.

Billups realized that his role in the program was lessening day by day. There was talk that the department might not even renew his scholarship for the following season.

So Herb Billups packed up and went home to Plainfield, N. J., as quietly as he could. He met with the coaches and departed just before the team left for a road game in Fresno last week.

Time will go on, the program will continue to flourish, and Herb Billups will be quickly forgotten. Already, he is nothing more than the name OTHERS in the UNR basketball statistics.

It is unfortunate that Billups saw UNR as just a place to play basketball and not an educational institution. "I can't complain," Billups said last year in an interview. "UNR has given me everything they promised; a chance to play basketball and an education." The education never came.

Boxing season is here again as the team has its first fight this Saturday in Berkeley. Coach Jimmy Olivas is sending seven boxers in the novice meet.

Cal Berkeley is now the only school in the West besides UNR that still has boxing as an intercollegiate sport, and UNR will fight them twice. In addition, the Pack will box the 12th Naval District team twice. Right now, Olivas is working on fights with Syracuse and West Point, both of which, according to Olivas, will be nationally televised. The nationals this year will be held at Annapolis.

The team for this first novice meet consists of Victor Alegria at 139 pounds, Steve Korcheck at 147, Dan Mathews at 147; Carl Mottcoll, 155; Roger Harrington, 165; Doug Paul 165; and Ken Della, 160.

Bob Kimberlin, the national boxing champ of a year ago at 112 pounds, thought that his boxing career was history after that championship bout.

But now it appears he may receive another shot at retaining his title. UNR is involved in a three-year boxing program and Kimberlin's three years were exhausted last year.

Back East, however, they are on a four-year program and the East will be the site of this year's championships. So Kimberlin will be eligible to participate for that one fight.

There is one hitch. His weight class is not the easiest in which to find fighters and as of right now, there is no one for him to fight.

But he is working out daily, waiting for that final shot.

Basketball's last call

Rodeo trip worthwhile

The UNR Rodeo Club has to be dedicated. Nine of its members traveled for 17 hours in a three-car caravan to Yuma, Ariz., last weekend and paid for their room and board for four days and entry fees of \$25 an event plus a \$5 fee stock charge. ASUN funded their travel expenses.

But it was worth it. Out of 18 schools from Nevada, California and Arizona, UNR placed close to the top. Fresno State took first place honors.

Scoring points for the Nevada women's team was Kathy Filippini in the barrel race. She placed third in one go-round with a time of 18.2 seconds. Her two-day average gave her a fourth place with a total time of 36.8.

Of the seven men who made the trip, four placed in steer wrestling, saddle bronc riding and team roping. John Johnson placed third in both go-rounds of steer wrestling and was second in the average from a field of about 30 competitors.

Roger Richards took fourth in saddle bronc riding out of 35 competitors and Reed Simmons and Gary Pointer placed second in the average for team roping. They competed among approximately 62 teams.

The rodeo was hosted by Arizona Western College.

The complete 1977 Wolf Pack football schedule has been released.

Trying to take advantage of his 7–0 home record in 1976, Coach Ault has scheduled only three road games. The Pack will take to the road against Cal Poly-San Luis Obispo, Santa Clara and UC Davis.

Padgett was drafted out of high school by the Houston Astros but turned down that offer to play basketball at UNR.

Well, last season, his basketball career ended and he was chosen in the basketball draft by the Warriors. But he was cut and returned to UNR to finish his education and also to get in a year in baseball.

But this January he was drafted for baseball again! It appears, though, that he has once again turned down that offer and will instead pitch a year for the Wolf Pack.

Will he be drafted again after this year? Four times would have to be some kind of record, for a UNR athlete at least.

After a non-conference stopover last week in Fresno, the 11-6 Wolf Pack basketball team will resume WCAC action tonight against St. Mary's here.

UNR is second in its conference at 3-1, right behind the No. 1-ranked USF Dons. St. Mary's is 1-3 in conference play and 6-8 overall.

If the Pack keeps up its current trend, then the game should be a close one. Of its last five games, four have been decided in overtime or by three or fewer points.
