The office of ASUN president holds great potential for more active representation, especially during the coming legislative year. I'm Heidi Waterman and I'd like to exercise that potential. Although I've been circulating my fliers and talking to as many students as possible during this last week, and realize there are a number of important subjects of interest to students, I'd like to reiterate some of the issues I believe should be addressed this year. I'm also ready to answer any questions you may have about my positions on any other issues.

Student Lobby—The USUNS organization (United Students of the University of Nevada System), which has never been utilized in a productive manner, should be continued and expanded, particularly for formation of an effective student lobby to support any issue which would benefit the entire University of Nevada System.

Library Support—It is vital that the new student president push for more legislative funding to both improve the UNR library collection and to increase library hours.

Campus Congestion—To ease automobile congestion—not just on campus but in the community at large—we should encourage and promote bicycling.

Athletic Funding—It is time to balance the presently disproportionate funding between men's and women's athletics, while helping to promote "minor" sports.

New Course Ideas—We should instigate more 'direct education' courses in which students interact with specialists on specific subjects of interest to the community involvement, shared knowledge, and mutual benefit.

The Student Press—During my years at UNR, I have seen regrettable and wholly unnecessary harrassment of campus journalists. I believe it is good to see the student press prodding and scrutinizing student politicians. It is time to respect freedom of the press on the campus.

A student body president must attempt to prevent student government isolation both from the students, who provide an endless source of energy and input, and the local and state government, who both monetarily and politically help determine the status of the university. I've been politically active during my three years at UNR, not only in student government, but in community politics as well. I'm currently a student senator (Arts and Science), an Activities Board member, an Academic Affairs Committee member, have been appointed to the Reno Municipal Commission on the Status of

Women, and have an intense interest in environmentally oriented projects.

I feel I can be a strong and effective leader both in continuing projects initiated by previous student administrations, and in instigating change. I regard this office as more than just another administrative post—it is a form and platform for championing the interests of both the students and the whole campus community. I'd like to thank all the students who supported me in the primary election, and urge your support again during the general election.

STUDENT LOBBY:

FOOD CONDITIONS:

I have heard a lot of comments from students about SAGA. SAGA's contract expires this year. I would gather information on what students feel are the areas that need the most improvements and with this information I would state our position and negotiate for better conditions.

DORMS:

While education is important, so are our living conditions. In some of the dorms I have seen floors that need carpet, walls that need paint and rooms with broken furniture. I will bring these problems to the attention of the Regents and work towards getting funds to improve living conditions on our campus.

LEGAL AID:

This problem is nearing completion and should be publicized to insure that all students benefit from it. Also, adequate funding should be provided to allow the legal aid program to become established and possibly expanded.

TEACHER COURSE EVALUATION:

All students should have the opportunity to learn as much as possible about a professor's methods of teaching, the format and the content of any course before registering for it. I will continue the work necessary to make it a working reality.

MINOR SPORTS:

The Finance Control Board met with Dick Trachok and discussed the possibility of setting up a committee composed of athletic department personal and members of student government. The goal of this committee is to see if the athletic department would be willing to contribute money to minor sports such as the soccer club, women's ski team, parachute club, karate club, etc. I would sit on this committee and try to get as much funding as possible.

These are some of the proposals and I am always

open for suggestions.

Over the past two years I have observed and communicated closely with members of ASUN in an attempt to attain an insight into student problems. Through this communication of student input I would like to see the following issues become reality:

1. I would like to see Sagebrush become a more financially self-sufficient entity. This could be accomplished by increasing the percentage of advertising

from its present level.

2. We must establish better lines of communication between Finance Control Board and Intercollegiate Athletics in order to obtain funding for club sports and insure more equal apportionment of funds for athletic and academic organizations.

3. I would work strongly with fellow officers and lobbyists to obtain funds from the legislature and Board of Regents for needed dormitory improvement.

4. In the future I would like to see the excess profits from the bookstore put to use in benefiting all members of ASUN. Two possible suggestions might be: 1) increasing our present investment and obtaining a higher rate of return, 2) setting up a rebate program whereby the money is returned to ASUN and allocations are increased.

I see the office of Vice President of Finance and Publications as one which has been and will remain to be responsive to student needs and desires. I will not pretend to know every problem and solution, but will be open, honest, and receptive to your expected goals and desire. General elections are Wednesday and Thursday in the student union, I would appreciate your vote.

As a candidate for the office of Vice President of Finance and Publications, I see many areas in which we can spend our money more effectively.

This year, as I sat on the Program and Budget and Activities boards we ran into the same problem time after time, clubs and organizations getting money for their programs and never letting these boards know what

happened with these activities.

Why should we concern ourselves with a \$22,000 profit from the bookstore that has already been spent when we should concern ourselves with a \$250,000 budget for next year. The money that we allocate to clubs and organizations should be given to those organizations that will use this money in the best interest of the students.

To say that we could sell 45% of the Sagebrush to advertising is absurd. We have to establish a policy of being able to collect the outstanding ads in the Sagebrush before we would go selling anymore. By selling more ads this would increase the already poor ratio of copy to ads.

To be able to get more funding for needed projects we must either increase per credit fees or have a stronger voice in Carson City during the Budget Planning for our

University.

I also support getting funding for the Legal Aide program, establishing an archives for University publications, and finding a permanent home for the Sagebrush, Artemisia, and Brushfire.

I have the experience to do the job and to do it well, please give me the chance.

Constitutional changes offered

(proposed changes indicated by asterisks)

ARTICLE I The Association

SECTION 100.0. This Association shall be known as the Associated Students of the University of Nevada, Reno, hereafter referred to as the ASUN.

SECTION 110.0. The purpose of the ASUN shall be:

110.1 To provide means for responsible and effective student participation in the organization and control of student affairs;

110.2 To provide an official and representative student organization with power to receive complaints, investigate student problems, and participate in decisions involving students;

110.3 To take action in the best interest of the student body and the uni-

versity community; 110.4 To provide an official voice through which student opinion may be expressed;

110.5 To provide means whereby students may gain experience and training in responsible political participation and community leadership; and

110.6 To foster awareness of the student's role in the campus, local, state, national and international communities.

**SECTION 120.0. Membership in the ASUN shall be automatic for undergraduate students registered for seven or more credits.

SECTION 130.0. A government of the ASUN is hereby established, whose purpose shall be to represent and act for the student body. This government shall function through:

130.1 A legislative branch, 130.2 An executive branch, 130.3 A judicial branch.

**SECTION 140.0. All elected members of this government shall be registered undergraduate students with an overall grade point average not lower than 2.2. All appointed members must be undergraduate students with an overall grade point average not lower than 2.0.

**SECTION 150.0. All members of the ASUN government shall be elected in the general election on the two days closest to March 15; they shall take office on the Wednesday closest to April 15.

SECTION 160.0. No member of the government may hold more than one elective ASUN position at one time.

**SECTION 170.0. No senator serving on the Publications Board will be allowed to serve on the staffs on any ASUN publications.

**SECTION 180.0. All meetings of the ASUN, including but not limited to the ASUN Senate, Activities Board, Finance Control Board, Publications Board, Program and Budget Committee and all Senate subcommittees, will be governed by "Robert's Rules of Order," latest edition.

> ARTICLE II The Legislative Branch

SECTION 200.0. The legislative branch shall be known as the Senate of the Associated Students of the University of Nevada, Reno, hereafter referred to as the Senate.

SECTION 210.0. The Senate shall be composed of not more than twenty (20) members of the ASUN as follows:

210.1 One (1) member to be elected

from within each college and recognized

210.2 The balance apportioned ong the colleges to approximate as closely as possible one (1) person, one (1)

SECTION 220.0. Every two (2) years, the Senate shall re-establish the number and the apportionment of the senators. This shall be done by a two-thirds (2/3) vote of the Senate membership.

**SECTION 230.0. Term of office shall be one year, but not limited to only one year for members of the ASUN Senate.

SECTION 240.0. Senate shall by a majority vote select three (3) individuals who shall re re-seated automatically to their respective boards, subject only to their re-election from their respective colleges. This shall be done no later than four (4) weeks prior to the ASUN primary election.

SECTION 250.0. The Senate shall have the following powers and duties:

250.1 To enact and amend statutes. Statutes will here designate those laws which implement provisions of the Constitution.

250.2 To endorse resolutions. Resolutions shall be formal expressions of opinion, will, or intent.

250.3 To formulate policies. Policies shall be defined as provisions and limitations on administrative procedure. 250.4 To make recommendations. Recommendations shall be expressions

of approval, disapproval or advice. 250.5 To issue directives. Directives shall state actions to be taken by executive officers or ASUN boards.

250.6 To approve by a two-thirds

(2/3) vote of the senators present all appointments of the executive officers. **250.7 To override the ASUN

President's veto by a two-thirds (2/3) vote of the members present.

250.8 To establish those committees necessary for its investigation and

250.9 To grant or refuse to grant recognition to all student organizations. 250.10 To try an elected officer of the ASUN upon his/her impeachment. **250.11 To approve the appoint-

ment of an Election Board Chairperson and Election Board members. 250.12 To fill any vacancies in the

ASUN government not otherwise provided for. 250.13 To direct the Election

referenda items. 250.14 To appoint investigative com-

Board to conduct special elections on

250.15 To subpoena any officer of the ASUN and records of the ASUN for testimony or evidence at any investigative hearing.

**250.16 The ASUN Senate shall be the sole judge of its own members and may discipline its members for any conduct unbecoming a member of that body. The member may be censured by a majority vote of members present and may be expelled by a two-thirds (2/3) vote of those elected.

**SECTION 260.0. The Senate shall approve or disapprove the actions of the Finance Control Board, Activities Board, Publications Board and the Program and Budget Committee.

260.1 Approval or disapproval of board action shall require a majority of the Senate membership.

SECTION 270.0. The Senate at its first organizational meeting shall elect from its membership a President who shall serve as presiding officer and who shall have the following powers and duties: 270.1 To vote to make or break a tie

SECTION 280.0. Removal of the Senate President shall require a majority vote of the Senate membership.

SECTION 290.0. The Senate must have a quorum of two-thirds (2/3) of its membership to conduct business.

> ARTICLE III The Executive Branch

SECTION 300.0. The executive branch of the ASUN shall consist of the following officers:

300.1 The ASUN President. 300.2 The Vice President of Finance and Publications, 300.3 The Vice Presidnet of Activi-

**300.4 The Senate President.

SECTION 310.0. The executive branch shall administer the affairs of the ASUN and shall enforce all statutes enacted by the Senate.

SECTION 320.0. The powers and duties of the ASUN President shall be:

320.1 To act as the chief executive

320.2 To serve as the chairperson of the Program and Budget Committee; he/she may vote to make or break a tie

320.3 To serve as the chairperson of the Executive Council and as ex-officio member of all ASUN boards and commit-

320.4 To make all appointments except those specifically designated to another officer.

320.5 To veto any act, in part or in whole, enacted by Senate. If neither signed, nor vetoed, the act becomes effective in ten (10) days following its

**320.6 To serve as a non-voting member of the Activities Board, Finance Control Board and Publications Board.

SECTION 330.0. The powers and duties of the Vice President of Finance and Publications shall be:

330.1 To serve as the chief administrative officer of finance and publica-

330.2 To serve as chairperson of Finance Control Board and Publications Board and to vote only to make or break 330.3 To serve as a voting member

of the Program and Budget Committee. 330.4 To prepare a general budget for his/her term of office, which shall be presented to the Program and Budget Committee. This budget shall be printed and made available to all mem-

bers of the ASUN prior to September 1. 330.5 To serve as voting member of the Executive Council.

**330.6 To serve as ASUN President in the incapacity of the ASUN President or vacancy of the office of ASUN Presi-

**330.7 Any other duties that the ASUN Senate shall delegate to him/her.

SECTION 340.0. The powers of the Vice President of Activities shall be:

340.1 To serve as the chief administrative officer of activities sponsored by

340.2 To serve as the chairperson of the Activities Board, voting only to make or break a tie vote. 340.3 To serve as a voting member of

the Program and Budget Committee. 340.4 To prepare a general budget for his/her term of office, which shall be presented to the Program and Budget Committee. This budget shall be printed and made available to all members of the ASUN prior to September 1.

340.5 To serve as a voting member of the Executive Council.

**340.6 To serve as ASUN President in the incapacity of both the ASUN President and the Vice President of Finance and Publications or vacancies of the offices of both the ASUN President and the Vice President of Finance and Publica-

**340.7 Any other duties that the ASUN Senate shall delegate to him/her.

**SECTION 350.0. Term of office shall be one year, but not limited to only one year for executive officers.

SECTION 360.0 The executive officers must have these additional qualifications: 360.1 Upperclass standing in their colleges at the time of their election.

360.2 Membership in the ASUN for any two (2) semesters, including the semester during which the election is

**SECTION 420.0. The Finance Control Board shall have in its charge and control the administration of all ASUN finances appropriated to it by the Program and Budget Committee.

420.1 The Finance Control Board shall consist of the following voting members: one-third (1/3) of the membership of the ASUN Senate, as assigned by the Executive Council, the Vice President of Finance and Publications, who may vote only to make or break a tie vote, and who shall serve as chairperson. Non-voting members shall be the ASUN Mnager, any faculty advisors and the ASUN Administrative Secretary.

SECTION 570.0. All Special Hearing Boards shall have an explicit function as provided for by the Disciplinary Rules and Procedures of the University of Nevada.

ARTICLE VI Amendment, Initiative, Impeachment and Recall

SECTION 600.0. Amendment of this constitution shall require the following procedure: 600.1. Proposal by a two-thirds (2/3)

vote of the Senate membership, or 600.2 Proposal by a petition signed by ten percent (10%) of the ASUN membership, with at least one percent (1%) of

the signatures from each college. **600.3 Approval by a two-thirds (2/3) affirmative vote of those voting in the ASUN general election.

SECTION 620.0 Recall 620.1 Definition

**620.1A All the ASUN officers or senators are subject to recall by members of the ASUN.

**620.1B No officer or senator may be subject to recall before he/she has held office for two (2) months.

If ASUN has to watch its money this coming year, then budget cuts should come from the area of publications.

cap, then they should share in the funding.
